(herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Suzanne Sullivan and Amy P Gallup

(herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **SHELBY** County, Alabama, to-wit:

Lot 305, according to the Final Record Plat of Creekside, Phase 2, Part B, as recorded in Map Book 44, page 26, in the Probate Office of Jefferson County, Alabama (Bessemer Division), and as recorded in Map Book 39, page 58-A, in the Probate office of Shelby County, Alabama.

Mineral and mining rights excepted. Subject to: current taxes, conditions, covenants, easements and restrictions of record.

This covenant and agreement shall run with the land conveyed hereby as against Grantees, and all persons or entities holding under or through Grantees.

Grantor makes no warranty or covenant respecting the nature of the quality of the title to the property hereby conveyed other than that the Grantor has neither permitted or suffered any lien, encumbrance or adverse claim to the property described herein since the date of acquisition thereof by the Grantor.


