Managers

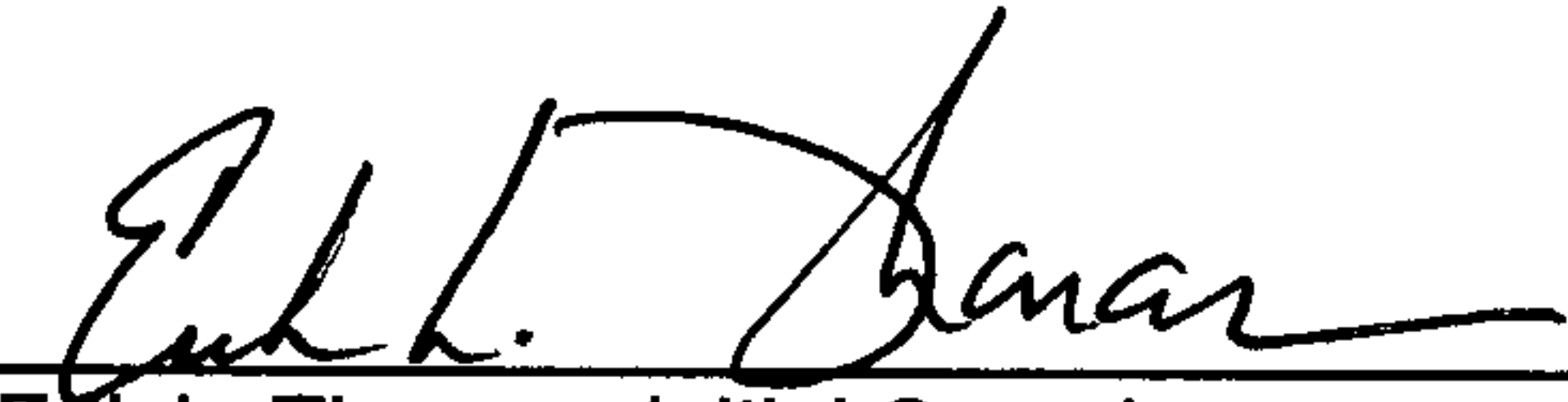
