**KNOW ALL MEN BY THESE PRESENTS:**

That in consideration of **Two Hundred Thirty-Seven Thousand Eight Hundred and 00/100 Dollars (\$237,800.00)**, which is the total purchase price, in hand paid to the undersigned Grantor(s) by the Grantee(s) herein, the receipt and sufficiency of which are hereby acknowledged, we, **Barry S. Jeffery, and Spouse, Margaret J. Jeffery** (hereinafter referred to as “Grantors”) do by these presents grant, bargain, sell, and convey unto **Wesley Miles Blankenship and Mary Pamela Blankenship** (hereinafter referred to as “Grantees”) as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama**, to-wit:



\$225,910.00 of the consideration herein was derived from a mortgage loan closed simultaneously herewith.

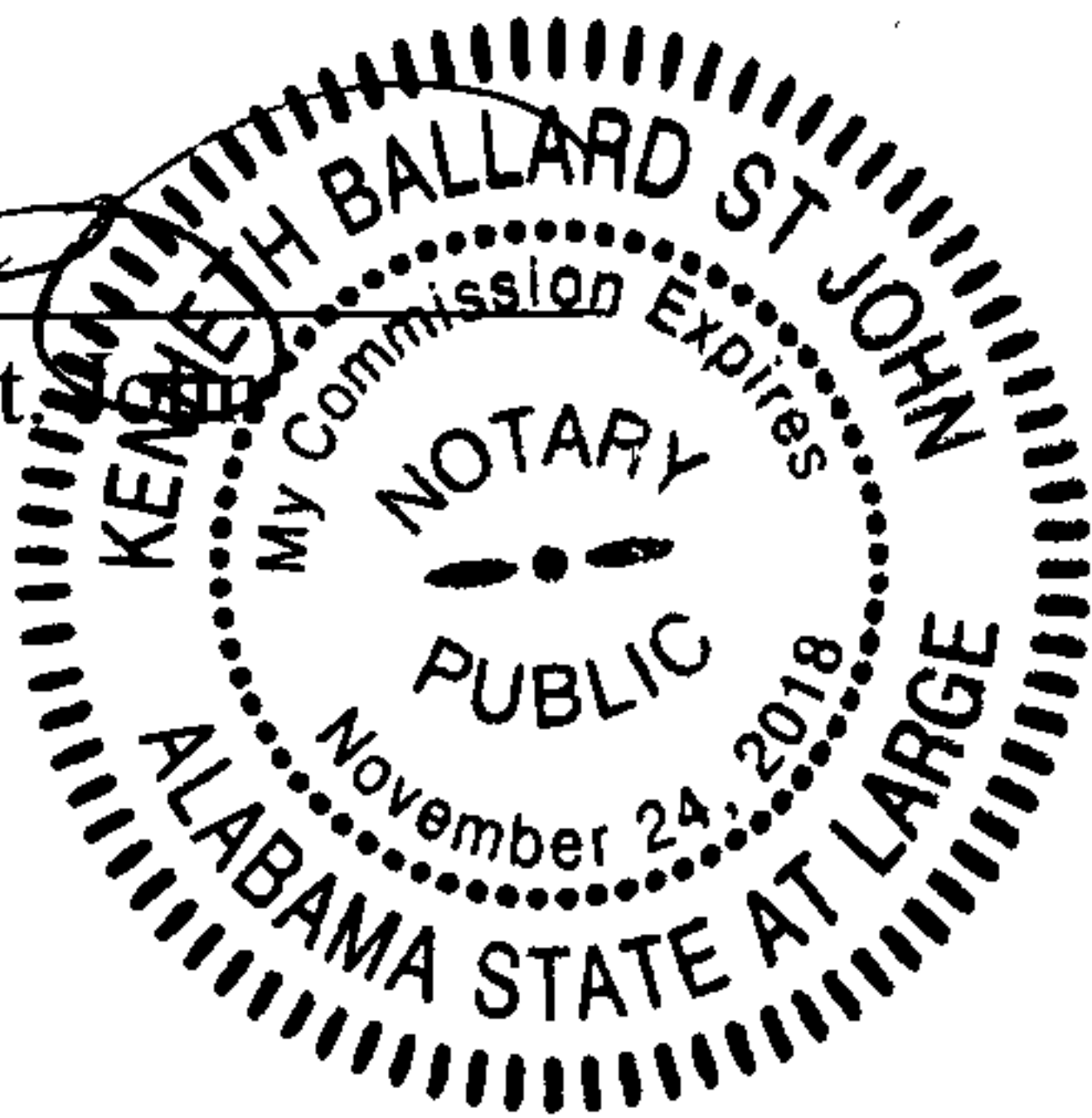
