





RESOLUTION NO. 071315

Whereas, on **November 24, 2014**, the Council, upon recommendation of the Abatement Board, declared the structure located at 23-1-01-2-002-008.001 owned by Triumph the Church and King of God in Christ to be unsafe to the extent of creating a public nuisance; and,

Whereas, the Abatement Board has made a report to the Council of the cost of demolition on said property in the amount of: **\$4,000.00**, giving credit for the proceeds from the sale of any salvaged materials, if any; and,

Whereas, the clerk published a notice in the Shelby County Reported on <u>June 24, 2015</u> that at the <u>July 13, 2015</u> meeting of the Alabaster City Council would consider fixing the costs of the abatement, said publication being more than 15 days before the meeting at which this Council would consider fixing costs against the property; and

Whereas, a public hearing was held thereon to consider any objections to the costs being assessed against the property on **July 13, 2015**.

NOW, therefore, after due consideration, BE IT RESOLVED,

- 1. That costs in the amount of \$4,000 for demolition, \$120 for legal fees and \$160.90 for advertising fees in the <u>total amount of \$4,280.90</u> are hereby assessed against <u>the structure located at 23-1-01-2-002-008.001 owned by Triumph the Church and King of God in Christ.</u>
- 2. That the City Manager is to hereby publish a copy of this resolution in the manner prescribed for the publication of municipal ordinances.
- 3. That the City Manager is hereby directed to mail a certified copy of this resolution by certified or registered mail to the person last assessed for ad valorem taxes on the property.
- 4. That the City Manager is hereby directed to file a certified copy of this resolution in the Probate Court of Shelby County, Alabama.
