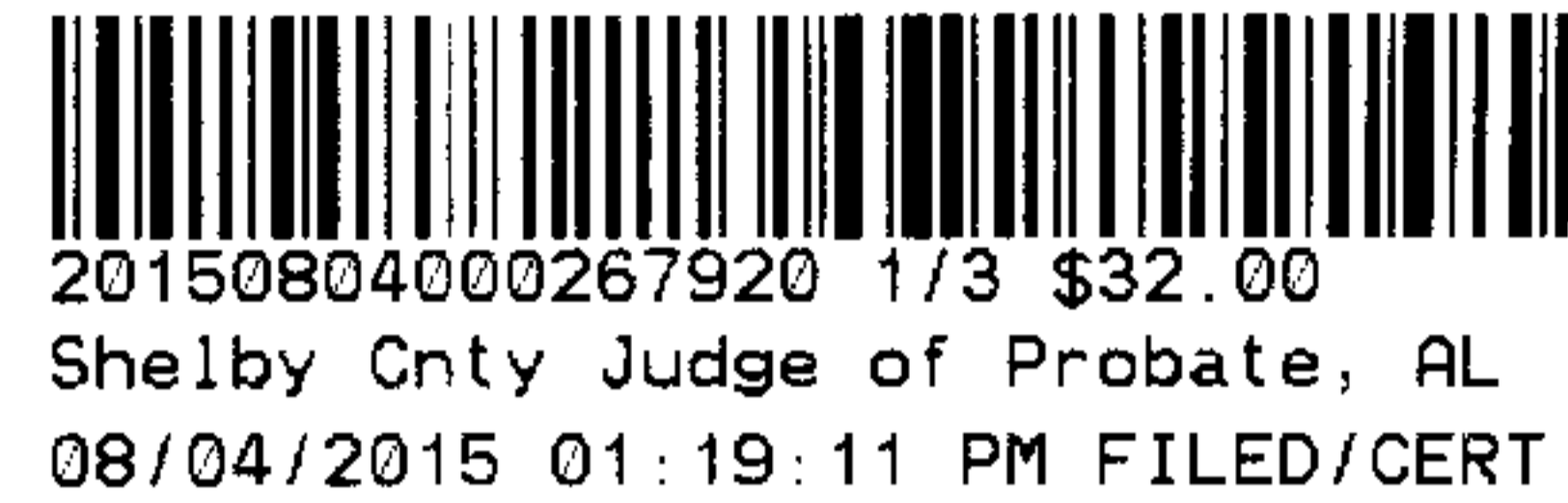

2. Easements, restrictions, reservations and conditions of record.


\$223,725.00 of the purchase price was paid from the proceeds of a purchase money mortgage closed simultaneously herewith.

The above described property does not constitute the homestead of the grantor or of said grantor's spouse.

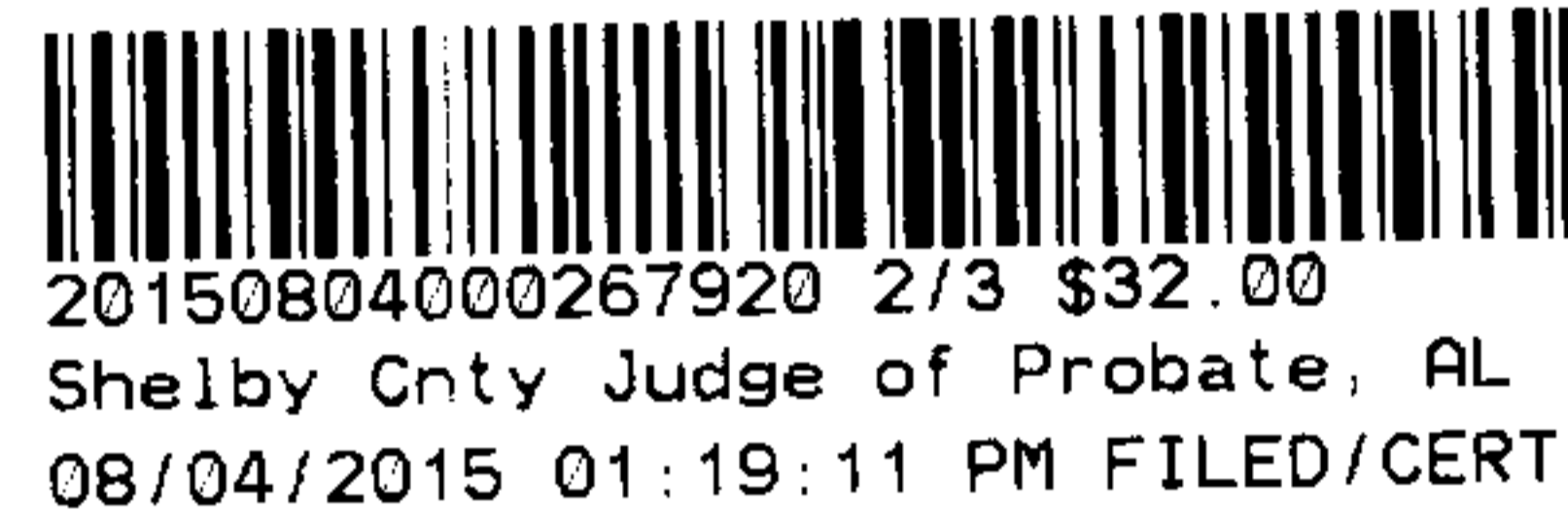


