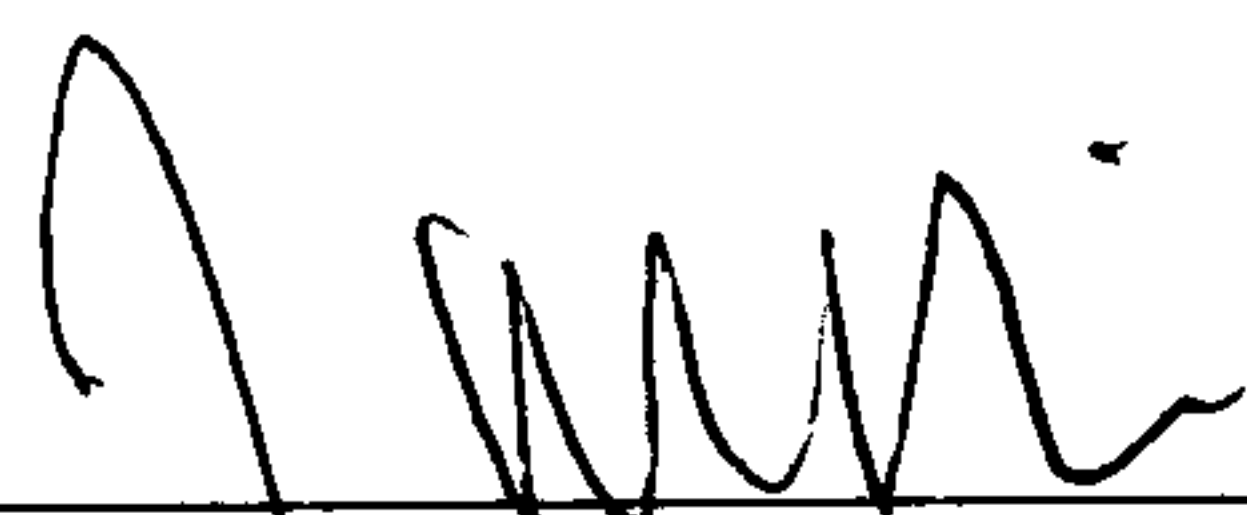
Subject To:

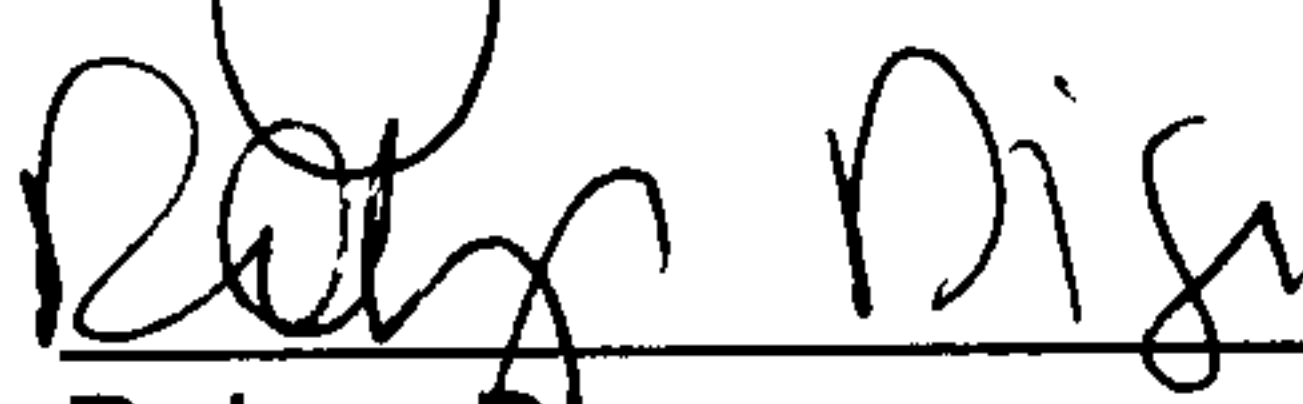

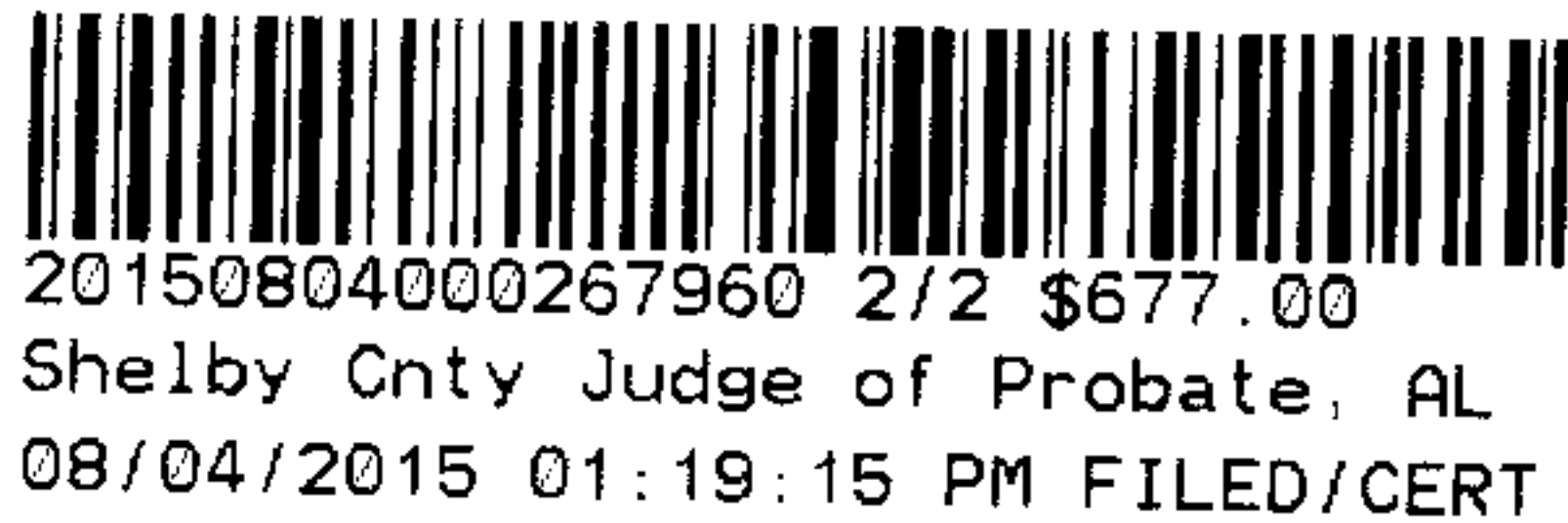
