ARTICLE I

NAME

The name of the limited liability company is JRT Wind, LLC.

ARTICLE II


PURPOSES AND POWERS

Section 1. In General. The object and purposes for which this limited liability company is organized are as follows:

- (1) The purpose of the Company is to conduct the business of buying, selling and holding investments, and to carry on any business whatsoever that it may deem proper or that it may deem calculated, directly or indirectly.
 - (2) To sue and be sued, complain and defend, in its name.
- (3) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal in and with real or personal property, or an interest in it, wherever



- (4) To sell, convey, mortgage, encumber, pledge, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.
- (5) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with shares or other interest in or obligations of domestic or foreign limited liability companies, domestic or foreign corporations, associations, general or limited partnerships, or direct or indirect obligations of the United States or of any government, state, territory, governmental district, or municipality, or of any instrumentality thereof.
- (6) To make contracts which are necessary or convenient to the conduct, promotion, or attainment of the business of the LLC not inconsistent with the provisions of the Constitution of Alabama as it may be amended from time to time.
- (7) To lend money for any lawful purpose, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
- (8) To conduct its business, carry on its operations, and have and exercise the powers granted by Act No. 93-724 in any state, territory, district, or possession of the United States, or in any foreign country.
 - (9) To elect or appoint managers and agents of the limited



liability company, and define their duties and fix their compensation.

- (10) To make and alter the operating agreement, not inconsistent with these Articles of Organization or with the laws of this state, for the administration and regulation of the affairs of the limited liability company.
- (11) To indemnify a member, manager, or employee, or former member, manager, or employee of the limited liability company against expenses actually and reasonably incurred in connection with the defense of an action, suit, or proceeding, civil or criminal, in which the member, manager, or employee is made a party by reason of being or having been a member, manager, or employee of the limited liability company, except in relation to matters as to which the member, manager, or employee is determined in the action, suit, or proceeding to be liable for negligence or misconduct in the performance of duty; to make any other indemnification that is authorized by the articles of organization, the operating agreement, or by a resolution adopted by the members after notice (unless notice is waived); to purchase and maintain insurance on behalf of any person who is or was a member, manager, or employee of the limited liability company against any liability asserted against and incurred by the member, manager, or employee in any capacity or arising out of the member's, manager's, or employee's status as such, whether or not the limited liability company would



have the power to indemnify the member, manager, or employee against that liability under the provisions of this subsection.

- (12) To cease its activities.
- (13) To have and exercise all powers necessary or convenient to effect any or all of the purposes for which the limited liability company is organized.
- (14) To become a member of a general partnership, limited partnership, joint venture or similar association, or any other limited liability company.

Section 2. Construction of Powers.

The foregoing clauses shall be construed as powers as well as objects and purposes, and the matters expressed in each clause, shall, except as otherwise expressly provided, be in no way limited by reference to or inference from the terms of any other clause, but shall be regarded as independent objects, purposes and powers; and the enumeration of specific objects, purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms of the powers of the company now or hereafter conferred by law, nor shall the expression of one thing be deemed to exclude another not expressed, although it be of like nature.


