ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION

OF

FarmerGuard Pest Control, LLC

Pursuant to the provisions of the Alabama Limited Liability Company Act, Code of Alabama, Sections 10A-5-2.02 et seq. (the "Act"), the undersigned hereby by adopts the following Articles of Amendment to the original Articles of Organization of the above Limited Liability Company.

- A. The original Articles of Incorporation were filed on March 19, 2009 in 20090319000102580 Shelby County Judge of Probate, 5 pages.
- B. The first amendment to the original Articles of Incorporation was filed on June 8, 2009 in 20090608000217340 Shelby County Judge of Probate, 2 pages.
- C. The following amendment was adopted in the manner provided for by the Alabama Limited Liability Company Act and the Operating Agreement of March 13, 2009:
 - Article V of the original Articles of Incorporation is hereby amended to state:

- D. The said, J.J. Patterson-Farmer, listed in the original Articles of Incorporation as an "initial member" is no longer a member of the Limited Liability Company, having sold her membership interest to Alan Farmer pursuant to the terms of

the Operating Agreement and an Ownership or Share Purchase Agreement dated July 27, 2015. With the sale of said membership interests, Alan Farmer now holds a 100% membership interest and membership right in the Limited Liability Company.


- E. This amendment, consistent with the Alabama Limited Liability Company Act, was approved by all the members as required by the Articles of Organization, the Operating Agreement and prescribed by law.
