MORTGAGE FORECLOSURE DEED

THIS INDENTURE, effective as of the 5 day of August, 2015, between U.S. Bank National Association, as Grantor, and U.S. Bank National Association, as Grantee.

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, November 23, 2010, **Dalton E. Ford, Jr., A Married Person, Mortgagor**, did execute a certain mortgage to **Homeservices Lending, LLC Series A DBA Homeservices Lending**, which said mortgage is recorded in Instrument No. 20101208000409970, in the Office of the Judge of Probate of Shelby County, Alabama.; and

WHEREAS, on July 16, 2015, the day on which the foreclosure sale was due to be held under the terms of said notice at 2:50o'clock am/pm, between the legal hours of sale, said foreclosure was duly and properly conducted and U.S. Bank National Association did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Pelham, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of U.S. Bank National Association in the amount of **THIRTY-EIGHT THOUSAND THREE HUNDRED EIGHTY-FIVE DOLLARS AND NO CENTS (\$38,385.00)** which sum the said U.S. Bank National Association offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said U.S. Bank National Association ; and
