
TO HAVE AND TO HOLD unto the said GRANTEE, her/his heirs and assigns, forever.

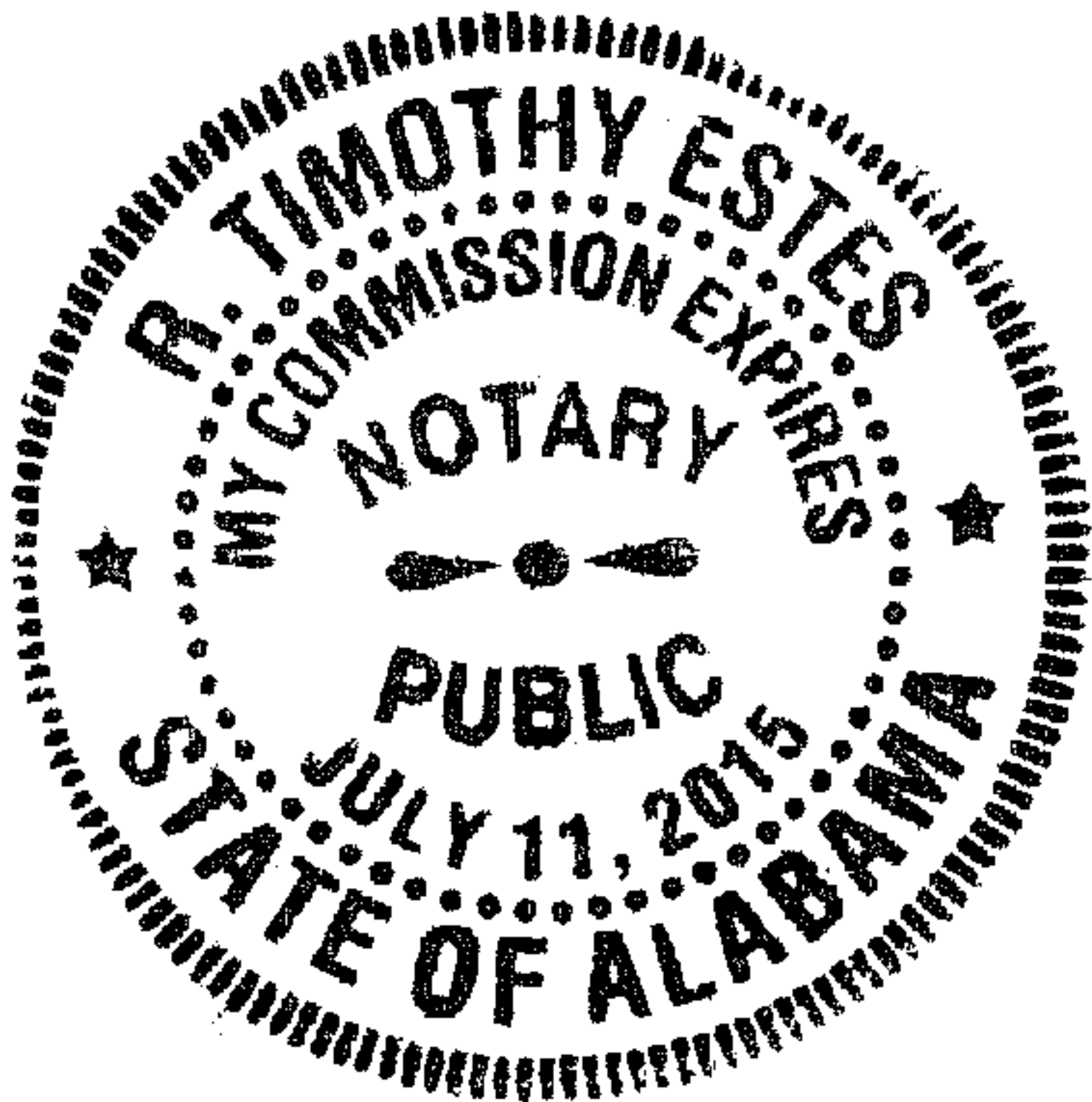



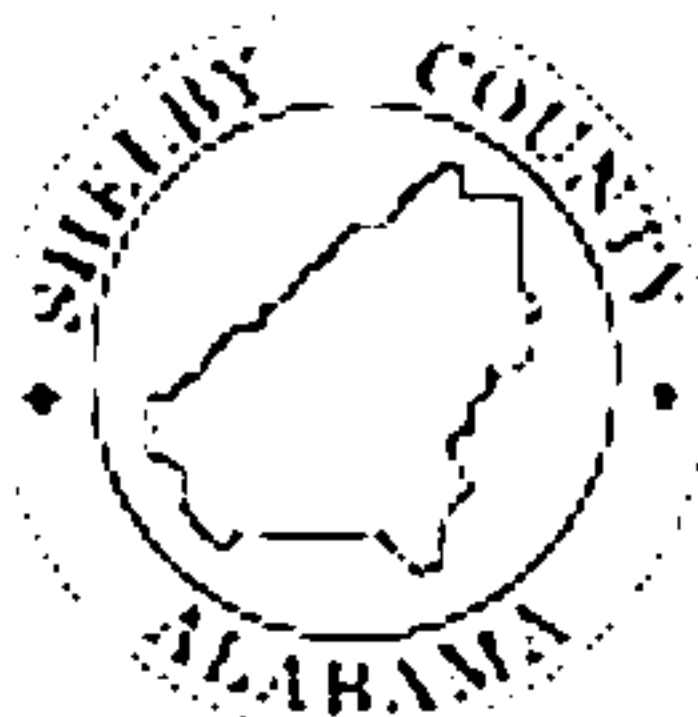
