

**ARTICLES OF ORGANIZATION OF
SHELBY EDUCATIONAL CONSULTING & TESTING, LLC**

Pursuant to the Provisions of Section 10-2-1, et seq., of Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

The name of the limited liability company is Shelby Educational Consulting & Testing, LLC (the "Company").

ARTICLE II

Duration

The Company shall have a duration from the date of organization until perpetual unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

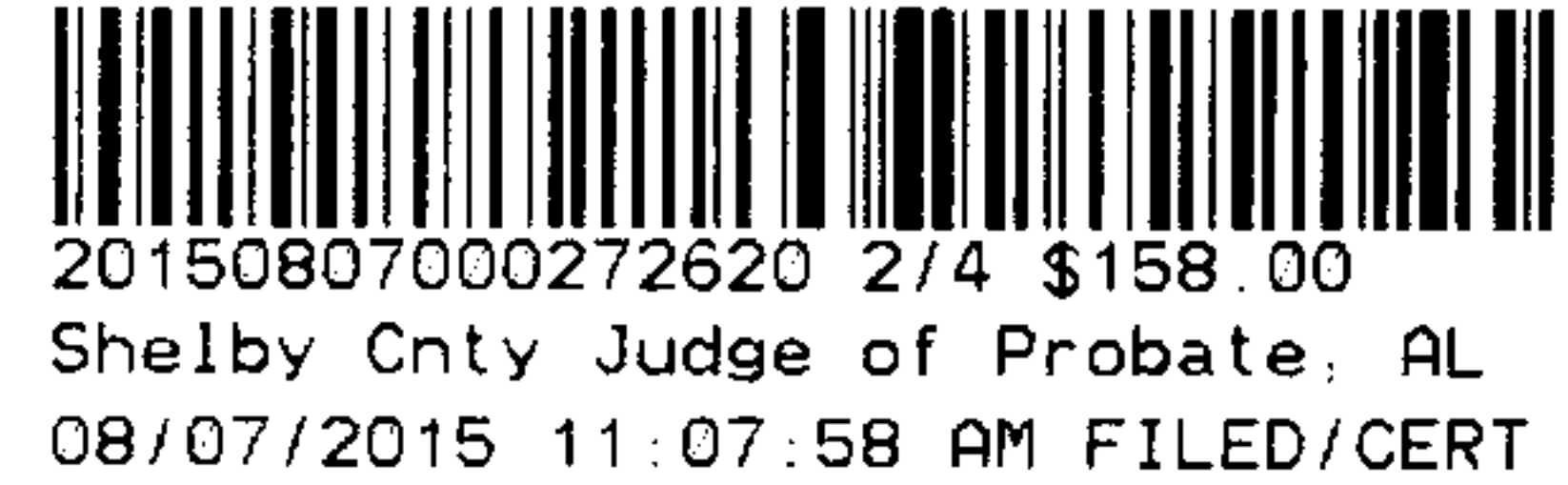
ARTICLE III

Admission of Additional Members

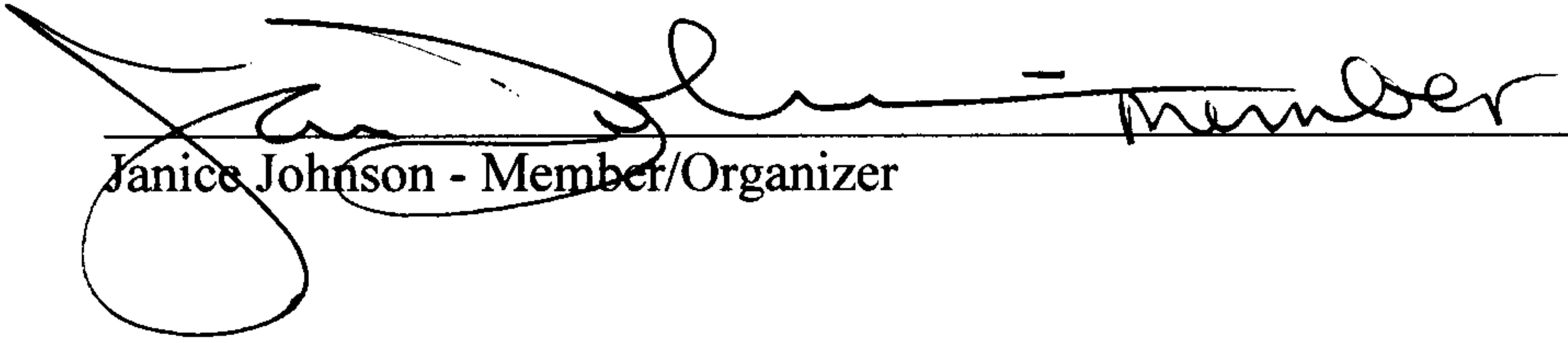
