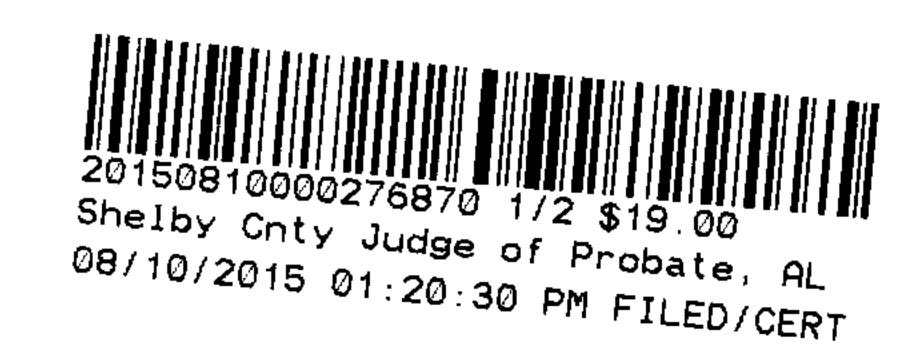
## WARRANTY DEED

ODOM, WIFE AND HUSBAND herein referred to as Grantor(s), do hereby GRANT, BARGAIN, SELL AND CONVEY unto MICHAEL S. JOHNSON, referred to as Grantee(s), his/her/their heirs and assigns, the following described real estate, situated in Shelby County, State of Alabama, to wit:

A METES AND BOUNDS RESURVEY OF PART OF LOTS 5 AND 6, IN BLOCK 16, OF JOSEPH SQUIRES MAP OF THE TOWN OF HELENA (ALABAMA), AS RECORDED IN MAP BOOK 3, PAGE 121 AND 121A, IN THE OFFICE OF THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA, MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCE AND BEGIN AT THE NORTHEAST CORNER OF LOT 5, BLOCK 16, OF SQUIRES MAP OF THE TOWN OF HELENA, AS RECORDED IN MAP BOOK 3, PAGE 121 AND 121A, IN THE OFFICE OF THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA; THENCE RUN WESTERLY ALONG THE NORTH LINE OF SAID LOT 5, 211.0 FEET TO A POINT; THENCE 82 DEGREES 10 MINUTES 13 SECONDS LEFT AND RUN SOUTHERLY 80.74 FEET TO A POINT; THENCE 97 DEGREES 49 MINUTES 47 SECONDS LEFT AND RUN EASTERLY PARALLEL WITH THE NORTH LINE OF LOT 5, 210.27 FEET TO A POINT ON THE WEST LINE OF SECOND STREET; THENCE 75 DEGREES 28 MINUTES 16 SECONDS LEFT AND RUN NORTH NORTHEASTERLY ALONG THE SAID WEST LINE OF SECOND STREET 82.63 FEET TO THE POINT OF BEGINNING; BEING SITUATED IN SHELBY COUNTY, ALABAMA.

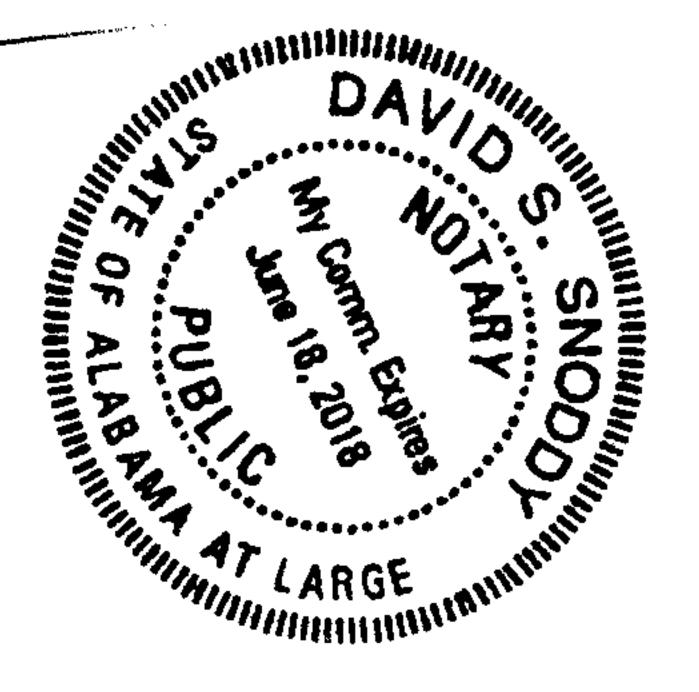
