ARTICLE I

The Name of The Limited Liability Company is:

ARTICLE II

DURATION

Unless terminated sooner by unanimous agreement of the members or by a provision of the operating agreement or a provision under the Alabama Limited Liability Company Act, the limited liability company known as **PEEK RENTALS, LLC** duration will be perpetual.

The Limited Liability Company has been organized for the following purposes:

b. The manager named in this Article VIII a. will serve for an indefinite period or until replaced under the provisions of the operating agreement of the PEEK RENTALS, LLC.

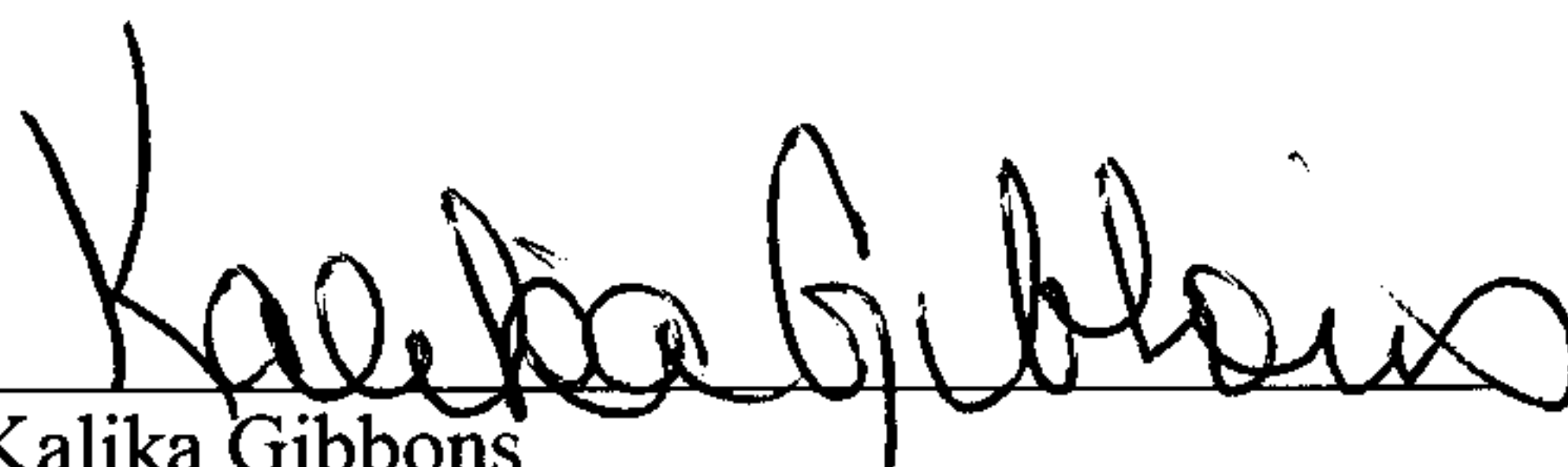
ARTICLE IX
