WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

Stevens and James D. Stevens, wife and husband, whose mailing address is 220 Queens Gate, Maylene, AL 35114** (herein referred to as Grantors), do grant, bargain, sell and convey unto **Carolyn Keith Davis and Larry Jerome Davis, wife and husband, whose mailing address is 146 Windsor Lane, Palham, AL 35124** (herein referred to as Grantees), for and during their joint lives as tenants and upon the death of either of them then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby, County, Alabama, **the address of which is 146 Windsor Lane, Pelham, AL 35124**; to wit;

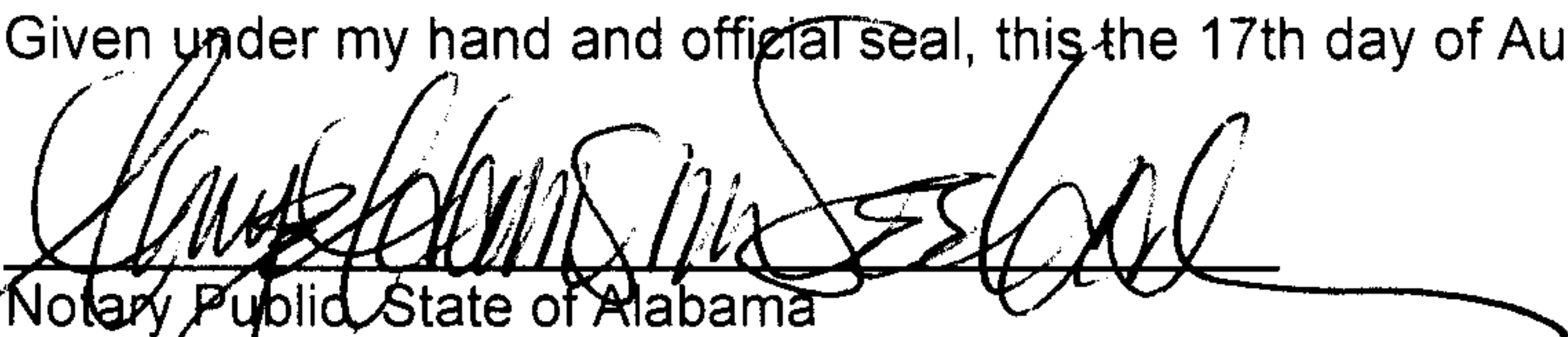

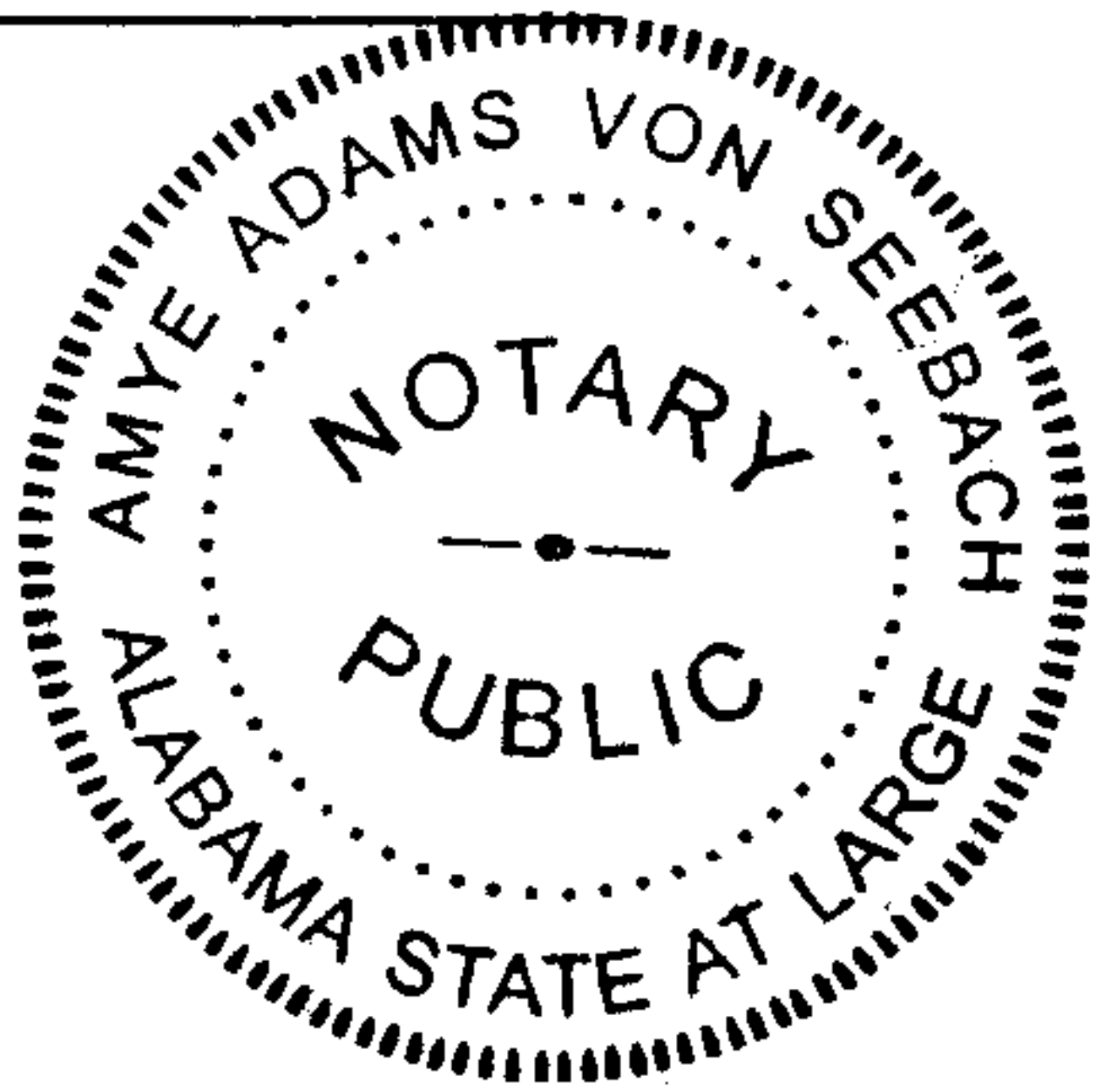

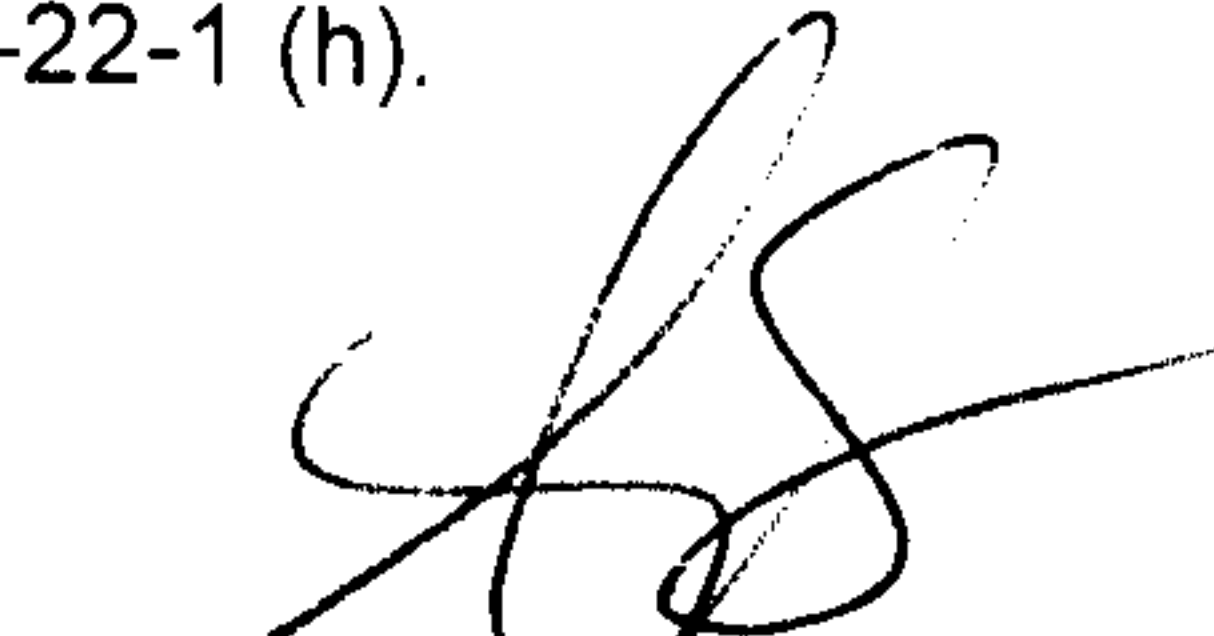
