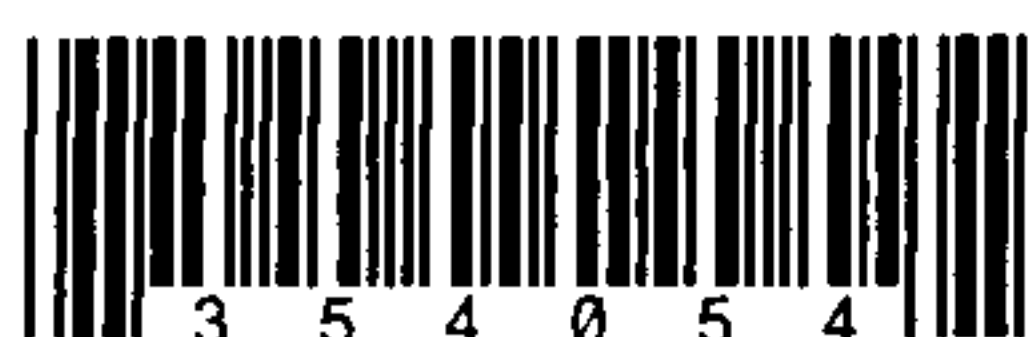
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 9th day of March, 2007, Tamil N. Harris, a married woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for First Federal Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070329000142410, said mortgage having subsequently been transferred and assigned to Federal National Mortgage Association, by instrument recorded in Instrument Number 20150226000060040, in the aforesaid Probate Office ("Transferee"); and
