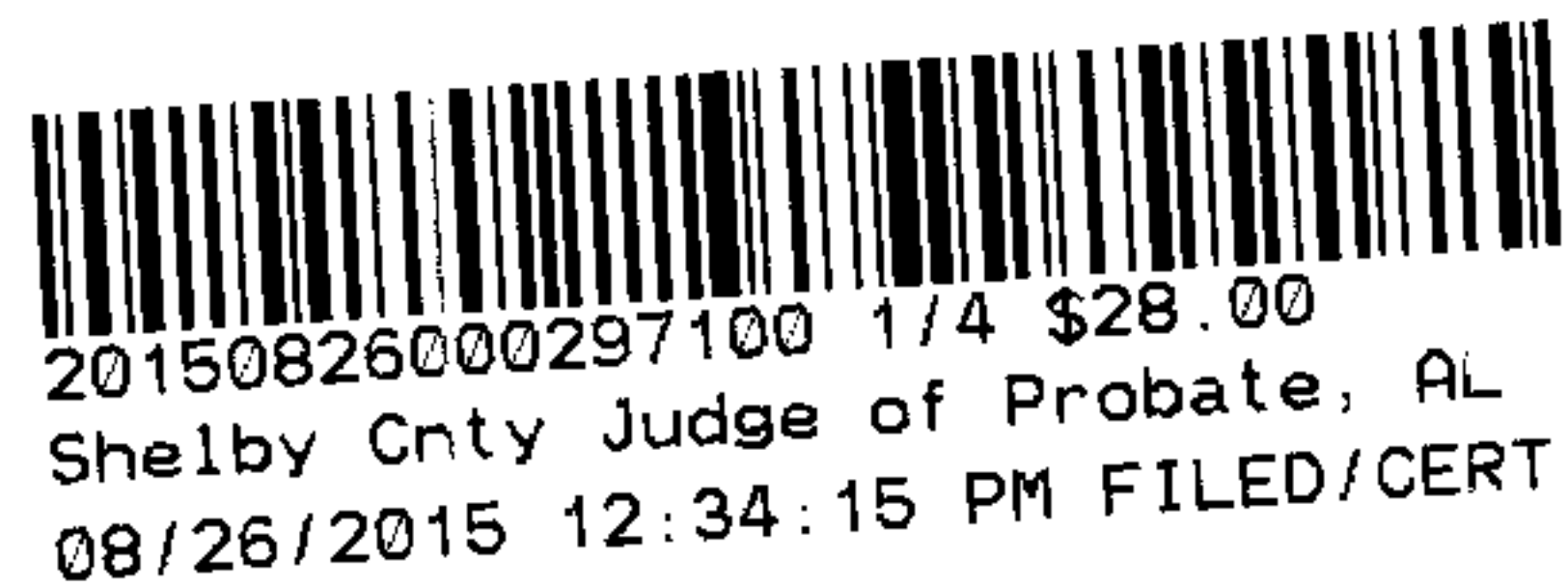


## FORECLOSURE DEED

### KNOW ALL MEN BY THESE PRESENTS:

**WHEREAS**, on to-wit, June 25, 2004, Kelly Fochtmann, a single woman ("Mortgagor"), executed a certain mortgage ("Mortgage") to Mortgage Electronic Registration Systems, Inc. solely as nominee for Castle Mortgage Corporation said Mortgage being recorded July 7, 2004, in Instrument Number 20040707000375320 in the Office of the Judge of Probate of Shelby County, Alabama; assigned to Green Tree Servicing LLC by instrument recorded in Instrument Number 20131021000416670 in the Office of the Judge of Probate of Shelby County, Alabama.


