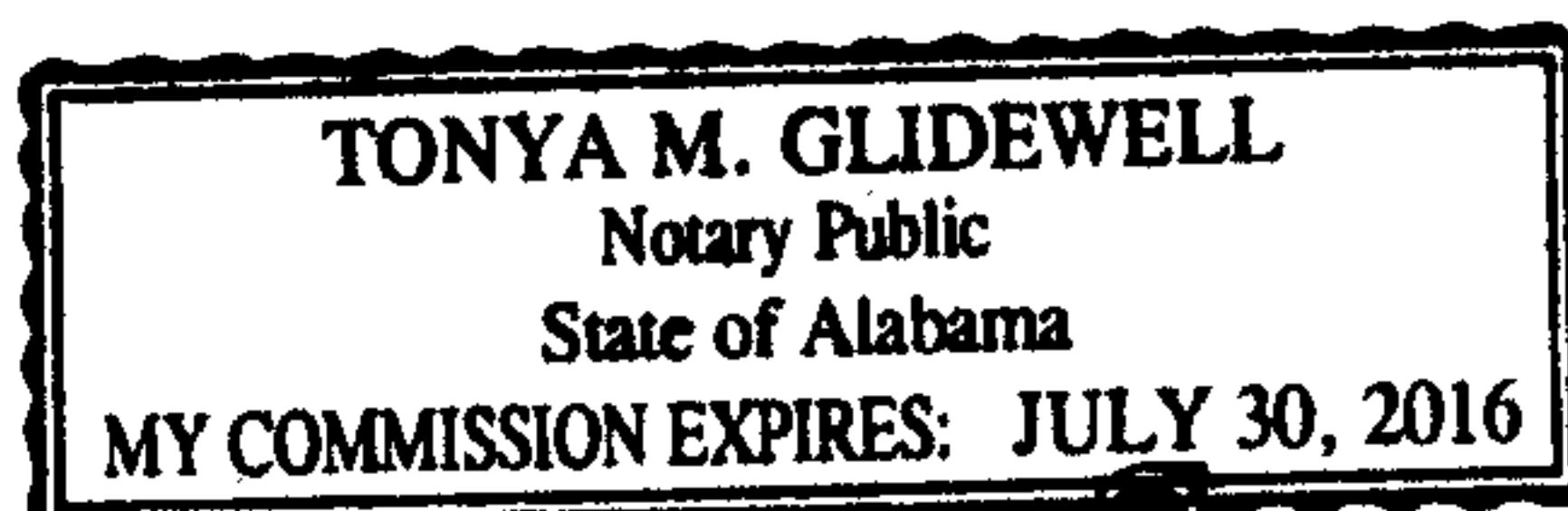
OATH OF OFFICE

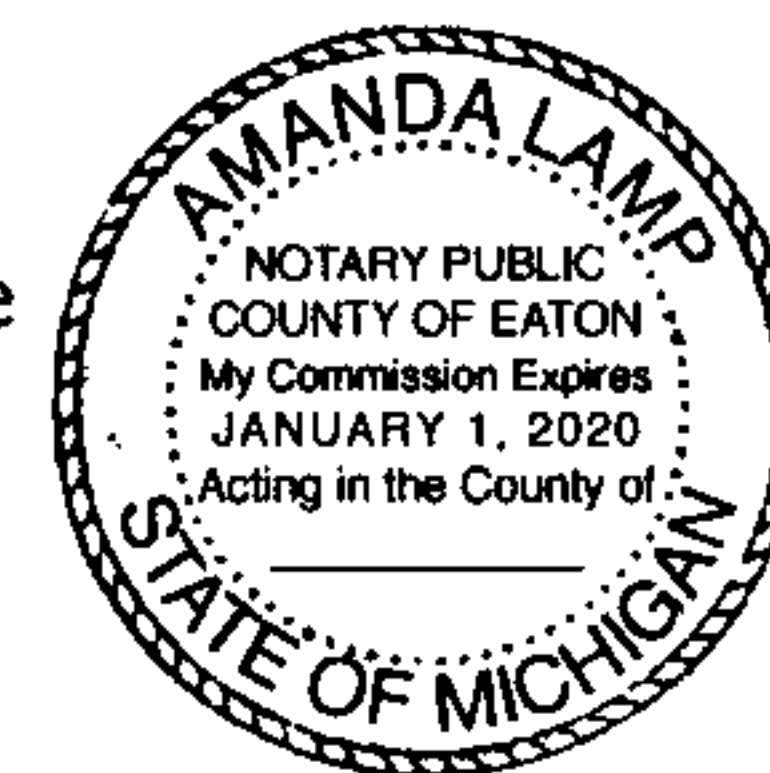
