That in consideration of **Two Hundred Ninety-Six Thousand and 00/100 Dollars (\$296,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

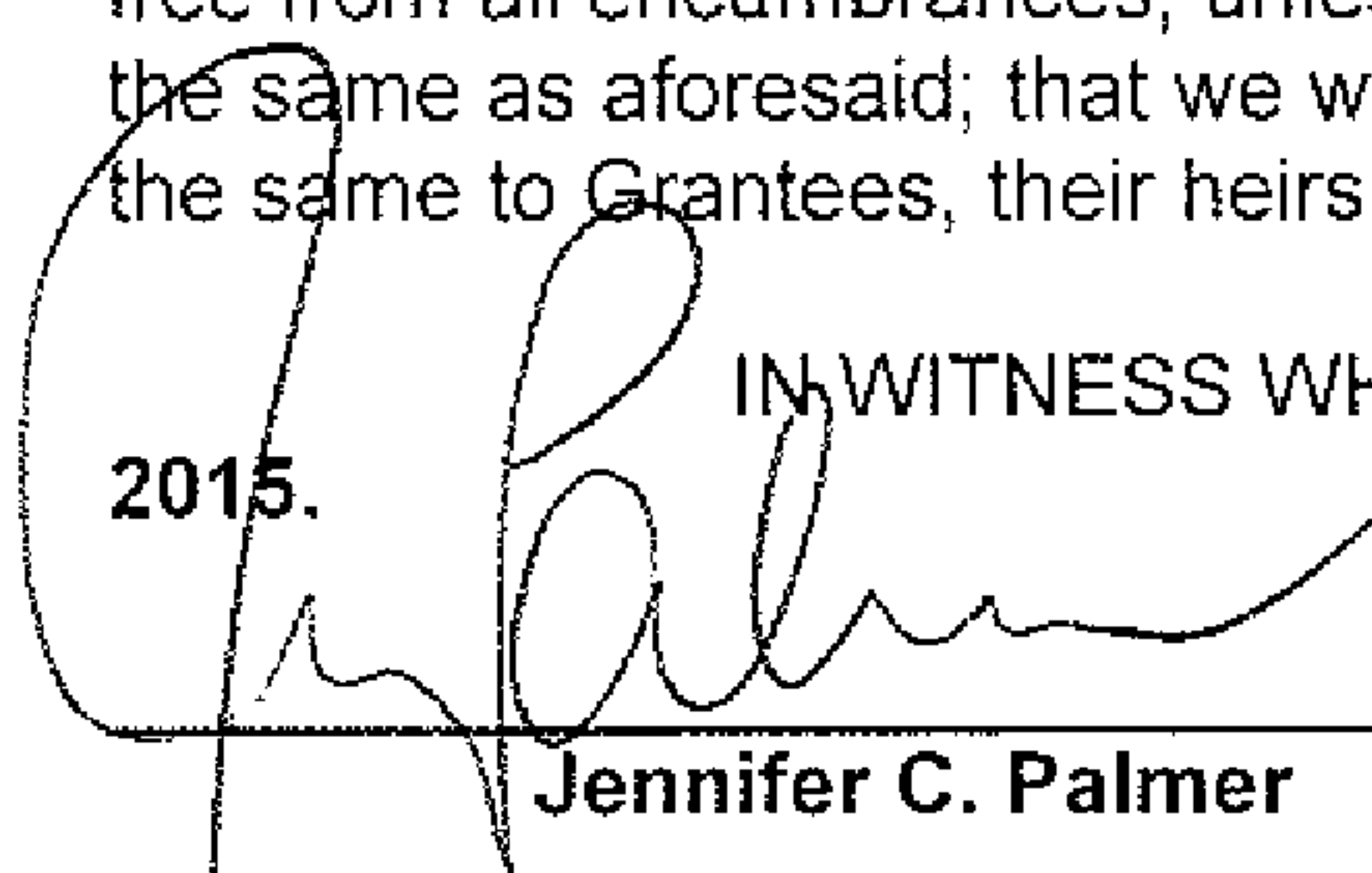
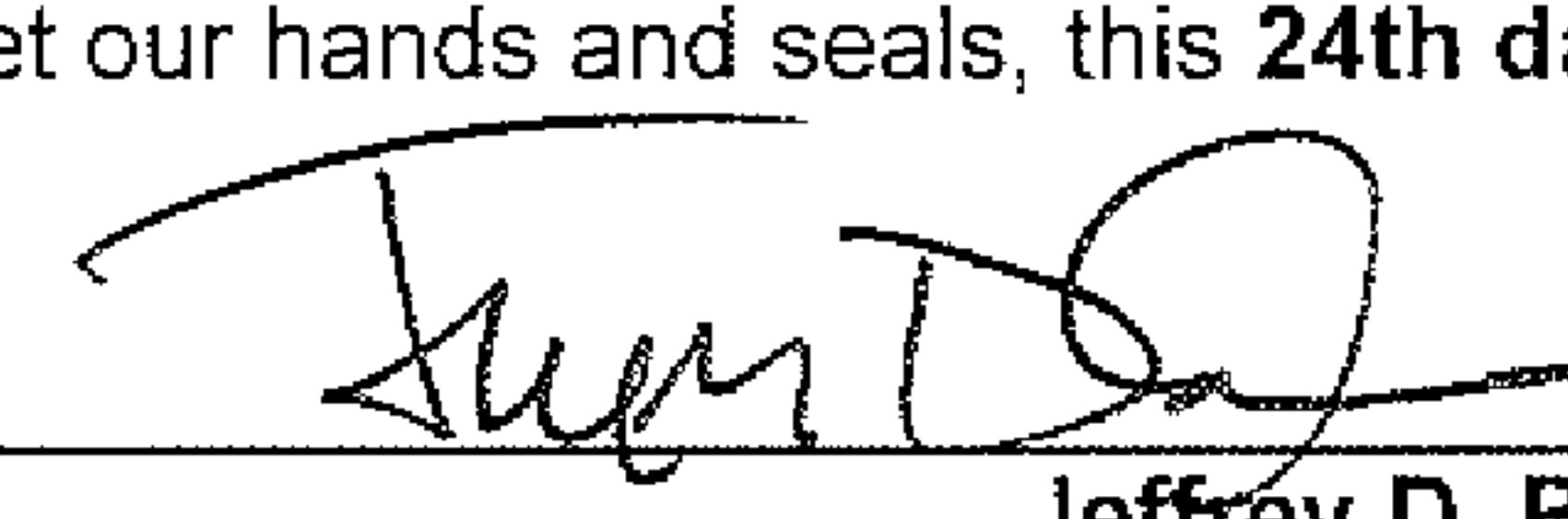
\$266,400.00 of the proceeds come from a mortgage recorded simultaneously herewith.

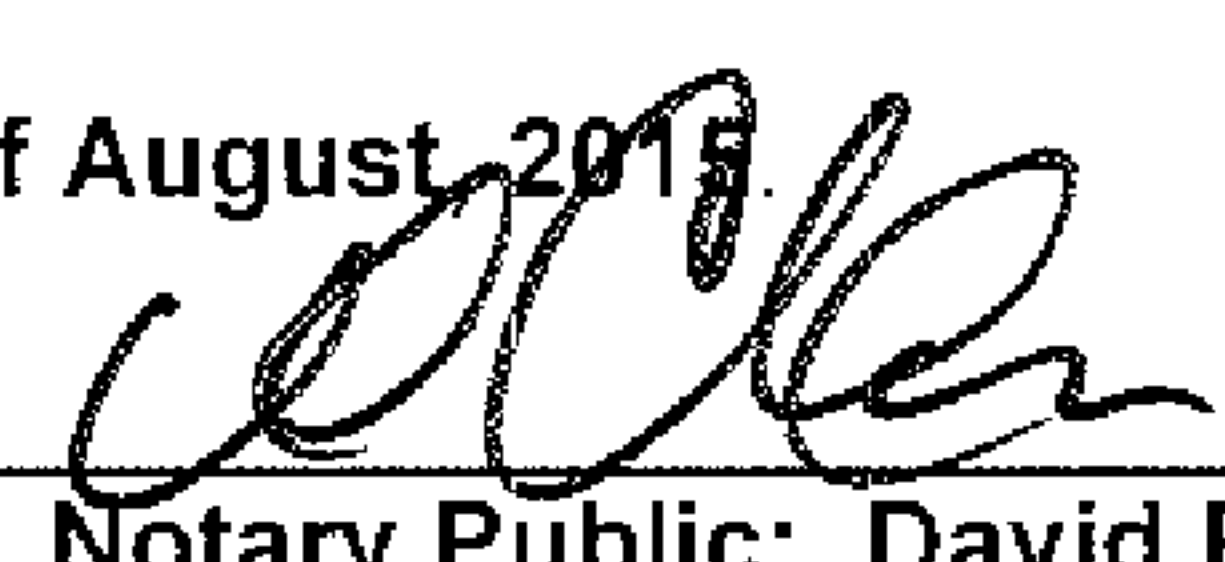
