

KNOW ALL MEN BY THESE PRESENTS, That in consideration of One Hundred, Fifty Thousand and no/100's Dollars (\$150,000.00) to the undersigned grantor,

in hand paid by the grantees herein, the receipt whereof is hereby acknowledged the said grantor does grant, bargain, sell and convey unto

Melissa G. Lumpkin and Frank L. Lumpkin

as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:


A parcel of land situated in the E ¼ of Section 17, Township 21 South, Range 4 West, Shelby County, Alabama, being more particularly described as follows:

arc of said curve and along said centerline a distance of 278.96 feet to a rebar capped EDG; thence N 14°18'41" E along said centerline a distance of 102.35 feet to a rebar capped EDG at the point of curve to the right having a central angle of 27°44'52" and a radius of 325.00 feet, said curve subtended by a chord bearing N 28°11'07" E and a chord distance of 155.86 feet; thence along the arc of said curve and along said right-of-way a distance of 157.39 feet to a rebar capped EDG; thence N 42°03'33" E along said centerline a distance of 105.57 feet to a rebar capped EDG at the point of curve to the left having a central angle of 27°09'55" and a radius of 325.00 feet, said curve subtended by a chord bearing N 28°28'35" E and a chord distance of 152.65 feet; thence along the arc of said curve and along said centerline a distance of 154.09 feet to a rebar capped EDG; thence N 14°53'38" E along said centerline a distance of 105.17 feet to a rebar capped EDG at the point of curve to the right having a central angle of 11°25'03" and a radius of 275.68 feet, said curve subtended by a chord bearing N 20°36'09" E and a chord distance of 54.85 feet; thence along the arc of said curve and along said centerline a distance of 54.94 feet to a rebar capped EDG at the point of reverse curve having a central angle of 58°40'25" and a radius of 100.00 feet, said curve subtended by a chord bearing N 55°38'54" E and a chord distance of 97.99 feet; thence along the arc of said curve and along said centerline a distance of 102.40 feet to a rebar capped EDG; thence N 84°59'06" E along said centerline a distance of 184.46 feet to a rebar capped EDG on the east line of said section; thence S 0°46'59" E leaving said centerline and along the east line of said section a distance of 1,965.17 feet to the SE corner of the NE ¼ -SE ¼ of said section; thence N 89°54'45" W along the south line of said 1/4-1/4 section a distance of 1,333.71 feet to the POINT OF BEGINNING. 


