Mooney Davis, unmarried (herein referred to as GRANTOR) does grant, bargain, sell and convey unto James Michael Mooney and Kimberly Mooney (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the right, title, and interest of the GRANTOR in and to the following described real estate situated in Shelby County, Alabama to-wit:

A parcel of land located in the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 14, Township 21 South, Range 2 West, Shelby County, Alabama, described as follows:

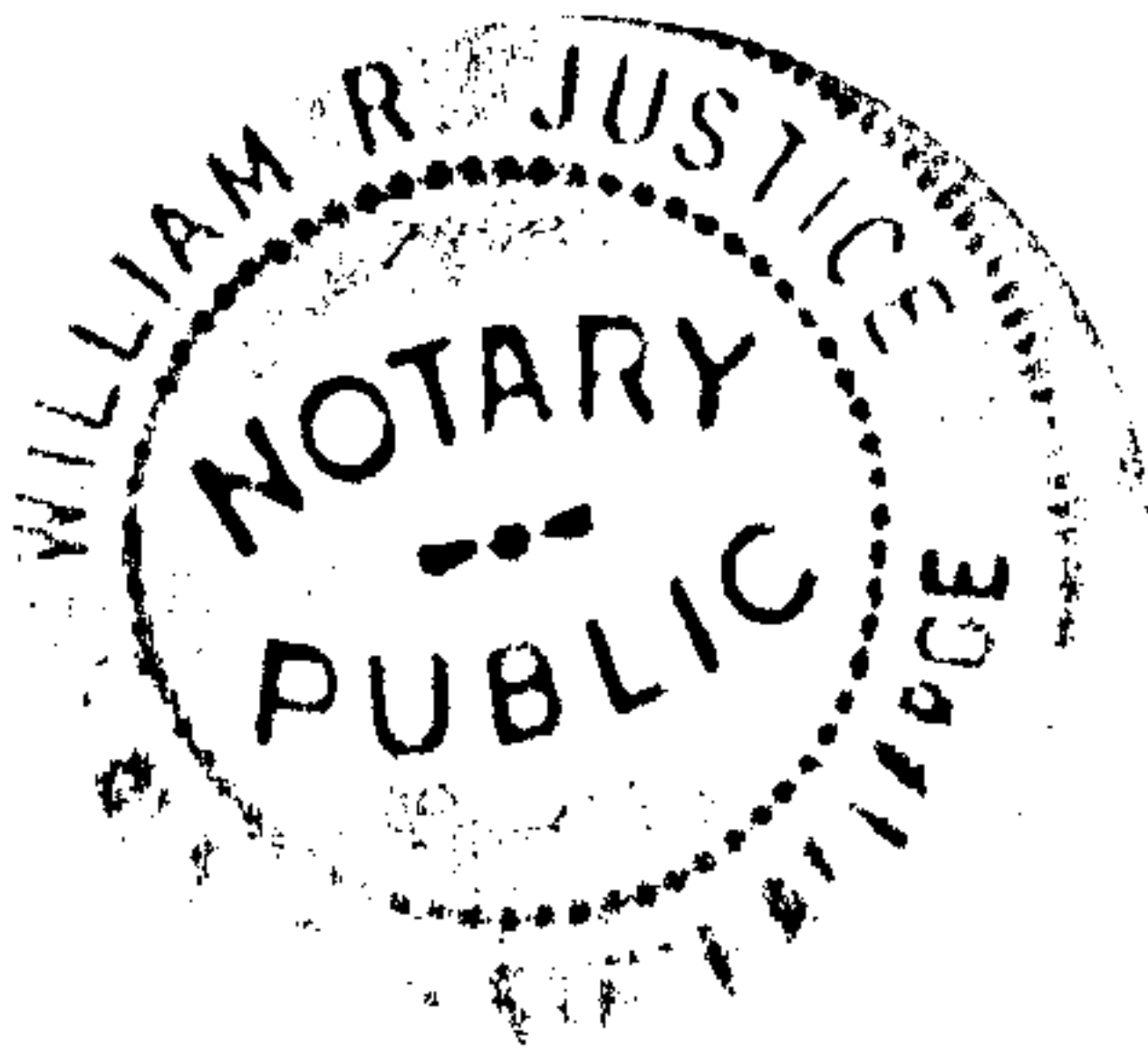
