**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF
SURVIVORSHIP**

SHELBY COUNTY KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One Thousand Three Hundred Twelve and 50/100 (\$1,312.50) to the undersigned GRANTOR in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, the undersigned Bruce Holcombe, married (herein referred to as GRANTOR) does grant, bargain, sell and convey unto James Michael Mooney and Kimberly Mooney (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the right, title, and interest of the GRANTOR in and to the following described real estate situated in Shelby County, Alabama to-wit:

A parcel of land located in the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 14, Township 21 South, Range 2 West, Shelby County, Alabama, described as follows:


Begin at the NW corner of said $\frac{1}{4}$ - $\frac{1}{4}$ Section; thence run East along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 252.28 feet; thence turn right 92 deg. 42 min. 22 sec. and run Southerly a distance of 430.68 feet to the Northerly right-of-way of Shelby County Highway No. 26; thence turn right and run along said right-of-way to the West line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section; thence turn right and run North along the West line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section to the point of beginning.

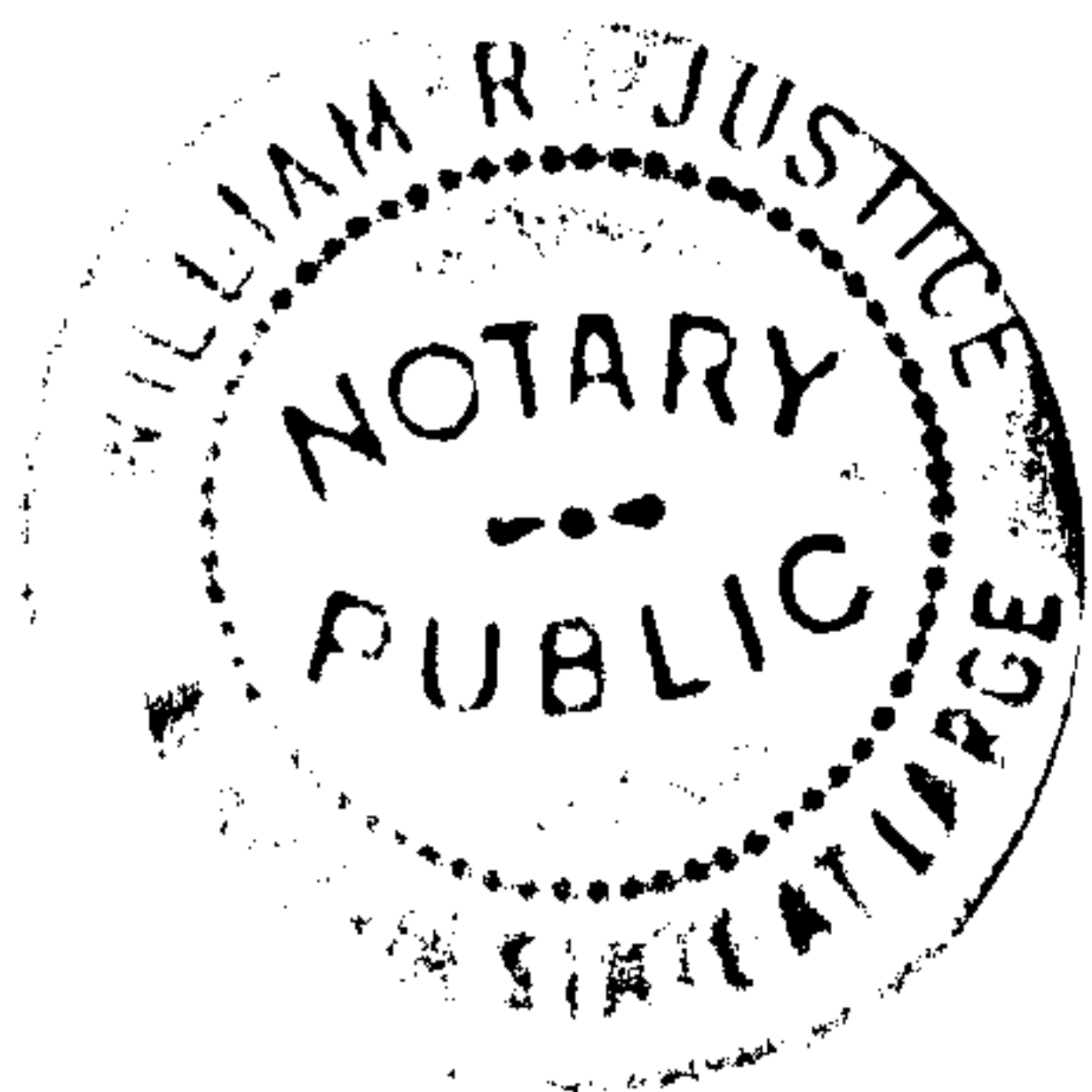
