KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of August, 2008, William T. Moor, a married person, Brenda Moor, a married person, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for SunTrust Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080829000346660, said mortgage having subsequently been transferred and assigned to Federal National Mortgage Association ("FNMA"), by instrument recorded in Instrument Number 20140730000235250, in the aforesaid Probate Office ("Transferee"); and


