PURPOSE: In order to form a limited liability company (LLC) under Section 10A-5A-2.01 of the Code of Alabama 1975 this Certificate Of Formation and the appropriate filing fees must be filed with the Office of the Judge of Probate in the county where the entity's initial registered office is located. **The information required in this form is required by Title 10A.**

Your entity will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored.

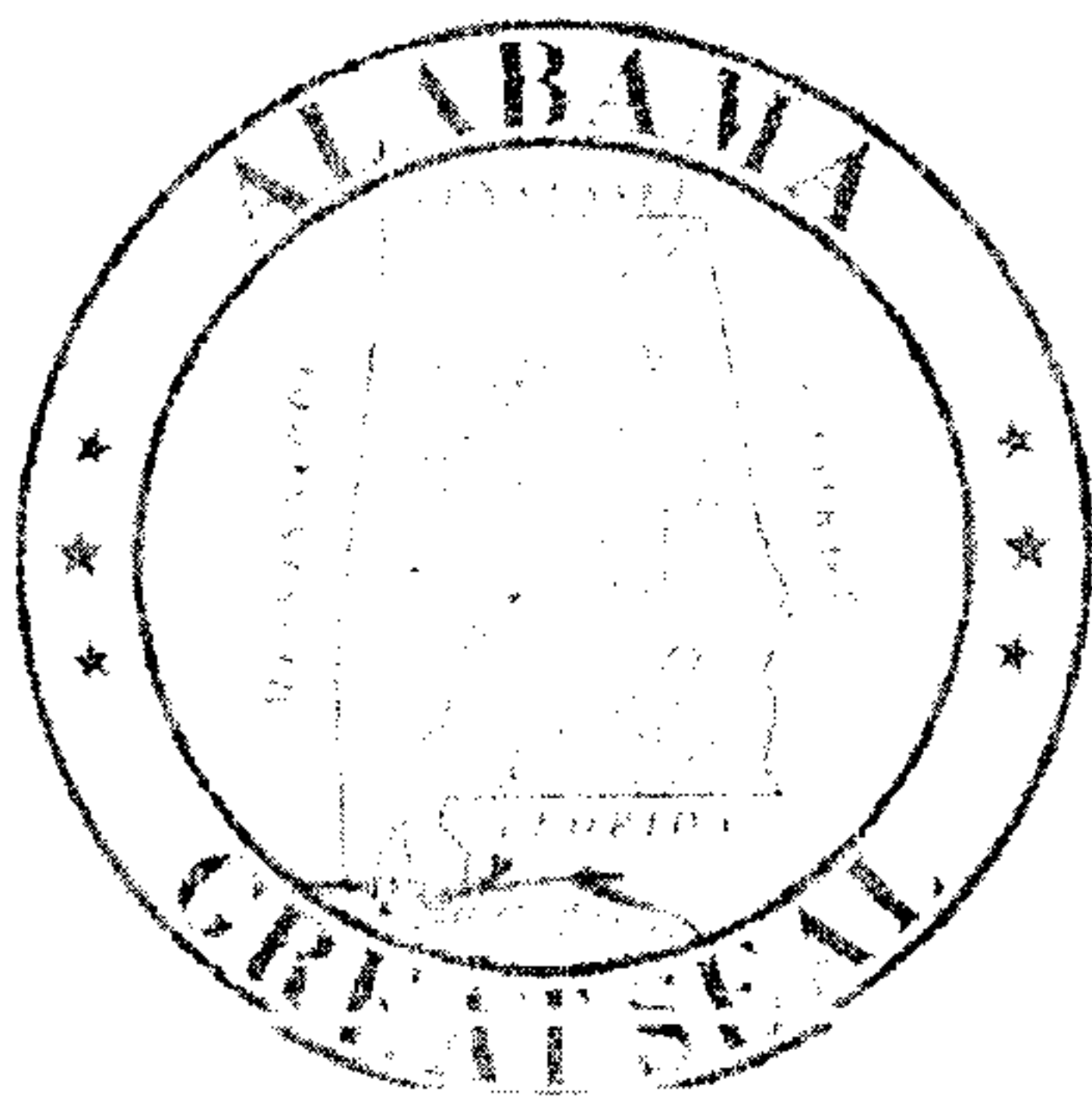

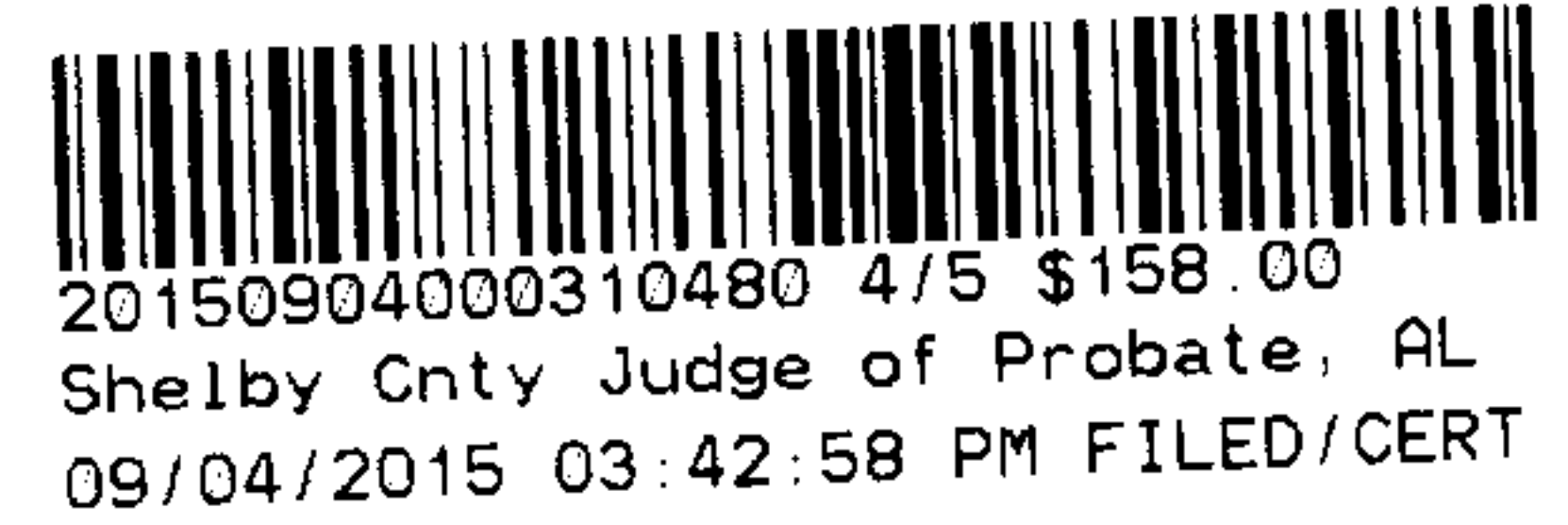

ARTICLES OF ORGANIZATION

OF

ESCAPE GRAPHICS, LLC



THE undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Alabama Code (1975), as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the Probate Judge of the County in which the initial registered agent of the limited liability company will be located and affirm that the facts in these Articles of Organization are true and correct:

ARTICLE I NAME

THE name of the limited liability company is **ESCAPE GRAPHICS, LLC**. (the "Company") doing business as **ESCAPE GRAPHICS, LLC**.

ARTICLE II DURATION

THE period of duration of the Company shall be from the date of filing of these Articles of Organization with the Office of Probate Judge for Shelby County, Alabama until the Company shall be dissolved pursuant to (a) the laws of the State of Alabama or (b) the Operating Agreement of the Company, as in effect from time to time. The period of duration is perpetual.

ARTICLE III PURPOSE

THE purpose for which the Company is organized are as follows:

- (1) To render services in the areas of graphic design and for any perpetual purpose.
- (2) To perform any and all business for which a limited liability company may be organized under the Alabama Limited Liability Company Act.
- (3) To accomplish any lawful business whatsoever or which shall at any time appear conducive to or expedient for the protection or benefit of the Company and its property
- (4) To exercise all other powers necessary to or reasonably connected with the Company's business, which may be legally exercised by a professional limited liability company under the Alabama Limited Liability Company Act or under the laws of any jurisdiction in which Company may conduct its business
- (5) To engage in all activities necessary, customary, convenient, or incident to any of the foregoing.

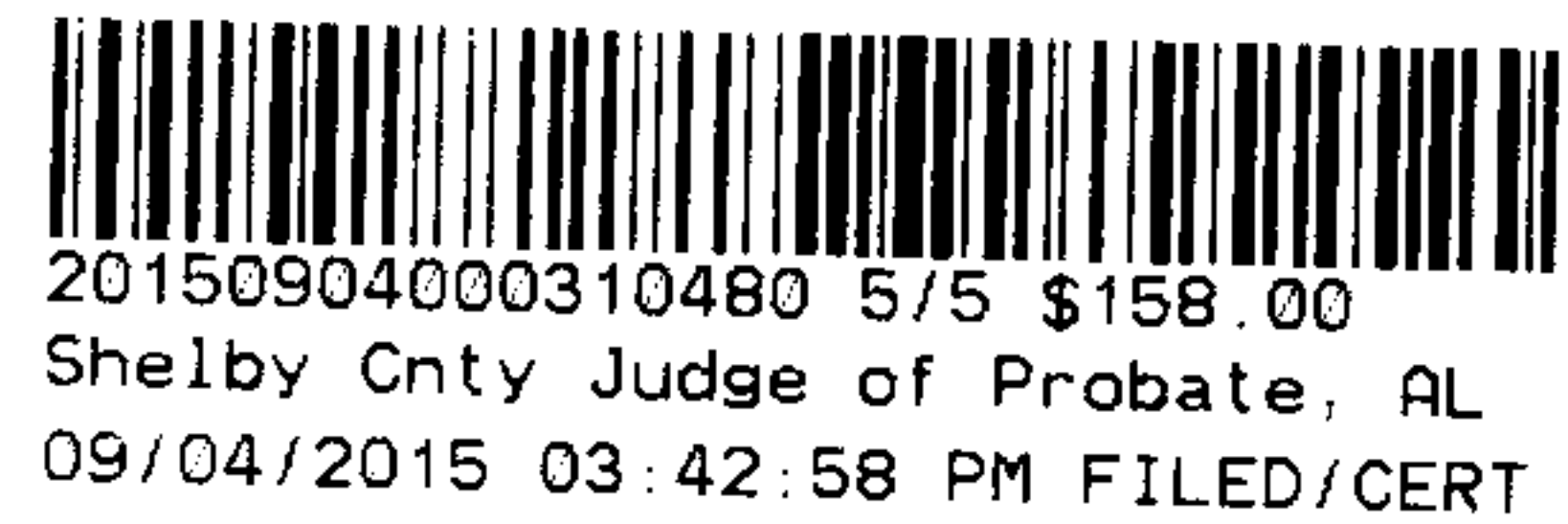

THE Company shall dissolve upon the cessation of membership of the last remaining members with the Operating Agreement of the Company.

ARTICLE VIII

UPON the demise of any member of the Company, said interest shall be inherited by Valencia L. Wells (on behalf of the interest of Willie Wells, III, Member Escape Graphics, LLC)

**ARTICLE IX
MANAGEMENT**

THE Company shall be managed by its members.

ARTICLE X

THE members of this Company shall have no liability for any debt, obligation or liability of the Company, except as provided in the Alabama Limited Liability Act.
