Lot 28, as recorded in Map Book 38, Page 1, Shelby County, Alabama records

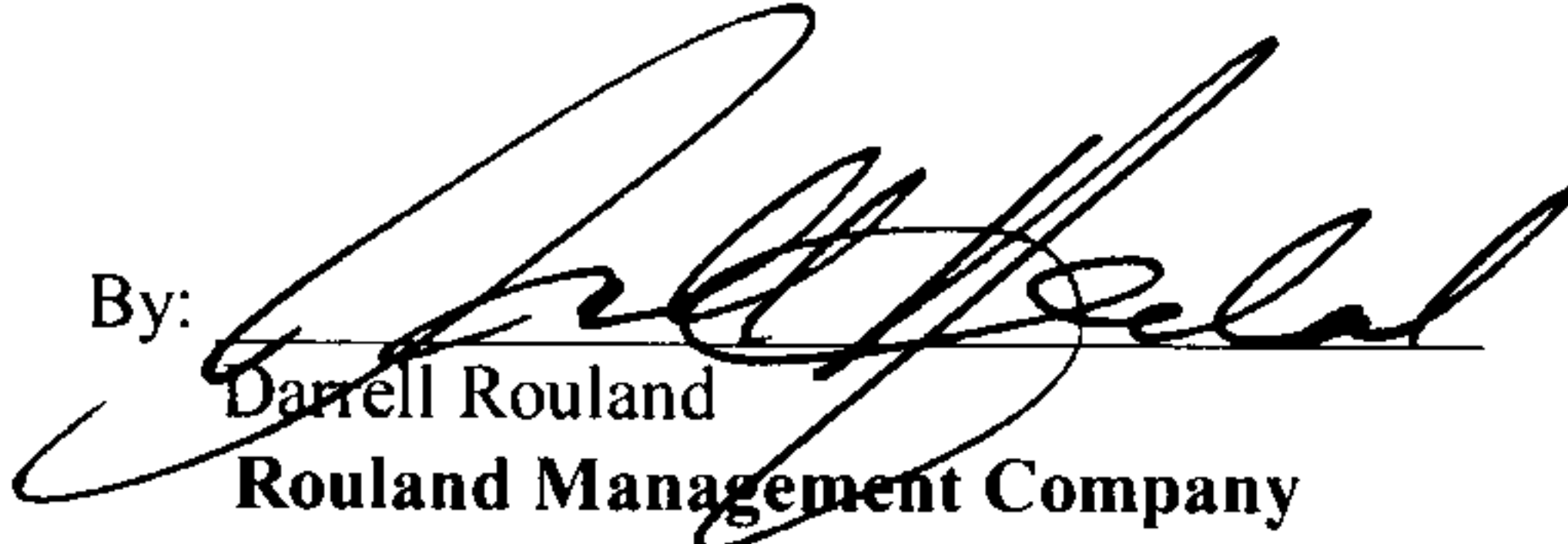

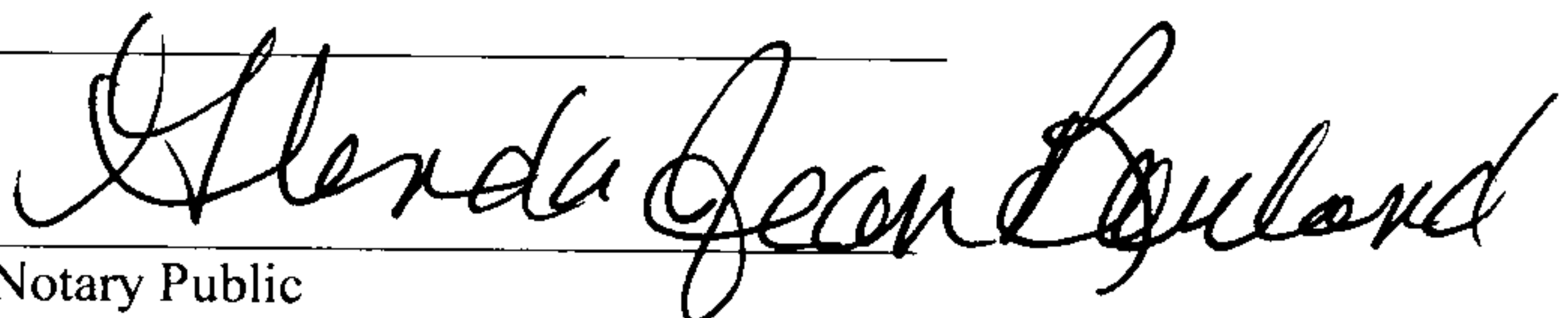
