The Association claims a lien upon property owned by **Kenyatta Randolph**, situated in Shelby County, Alabama described as follows:

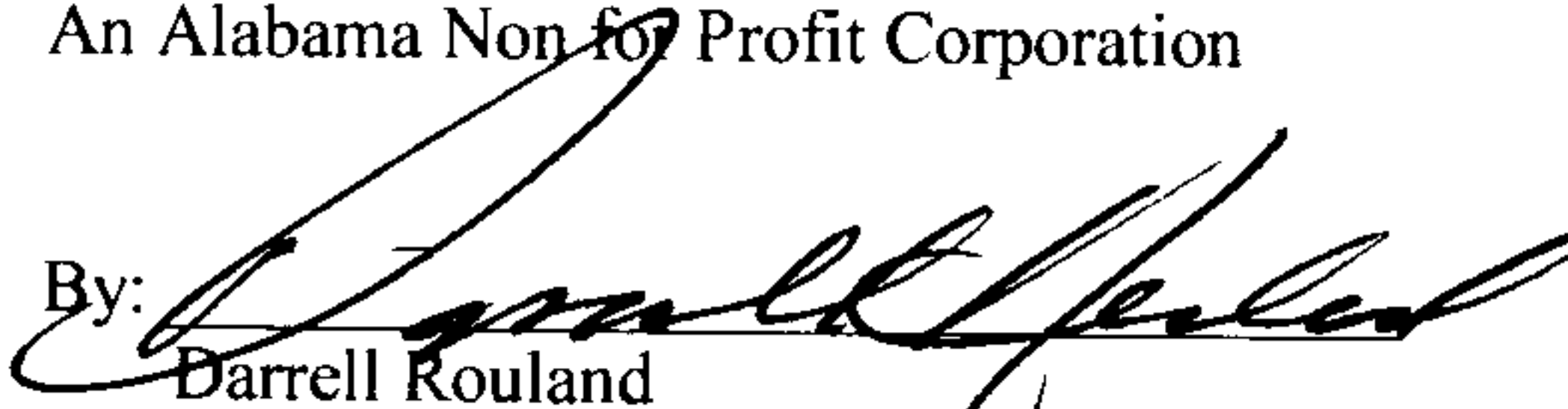

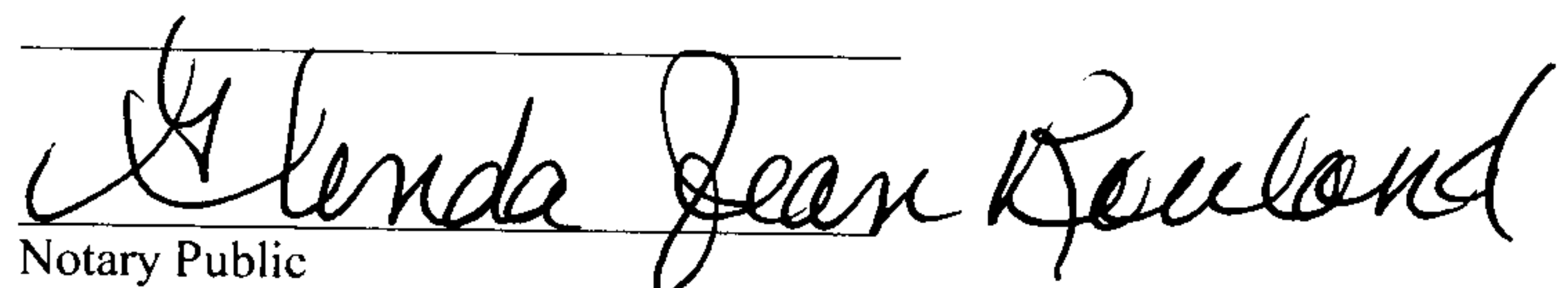
