The Association claims a lien upon property owned by **Ashley Walker**, situated in Shelby County, Alabama described as follows:

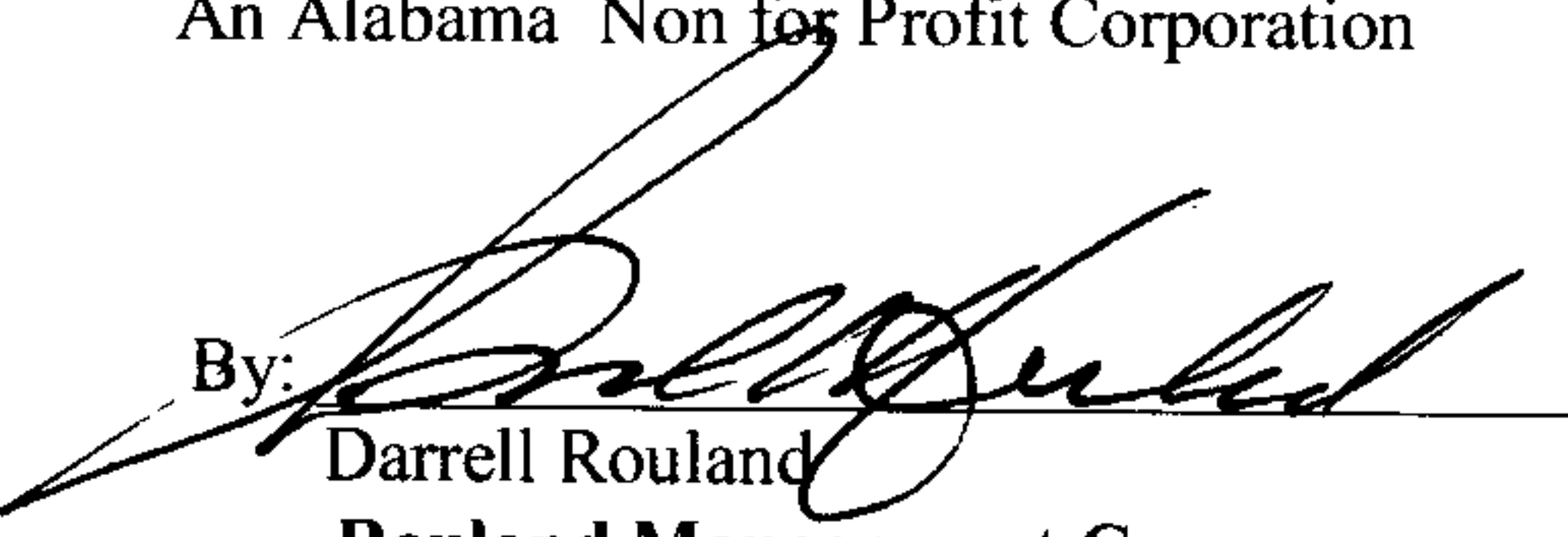

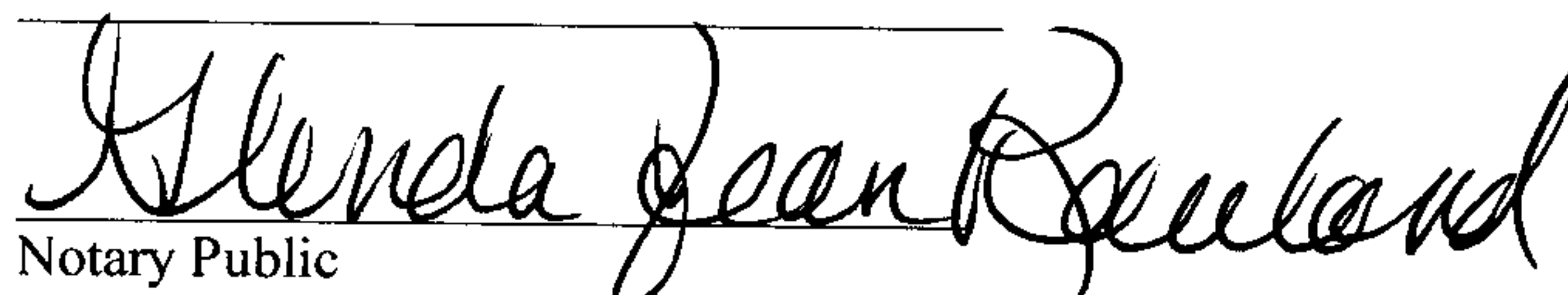
