Pursuant to the Provisions of Title 10A-5A-2.01, *et seq.* of the *Code of Alabama, 1975* (the "Alabama Limited Liability Company Law of 2014"), the undersigned hereby adopts the following Certificate of Formation for a Limited Liability Company.

## ARTICLE 1

### *Name*

## ARTICLE IV

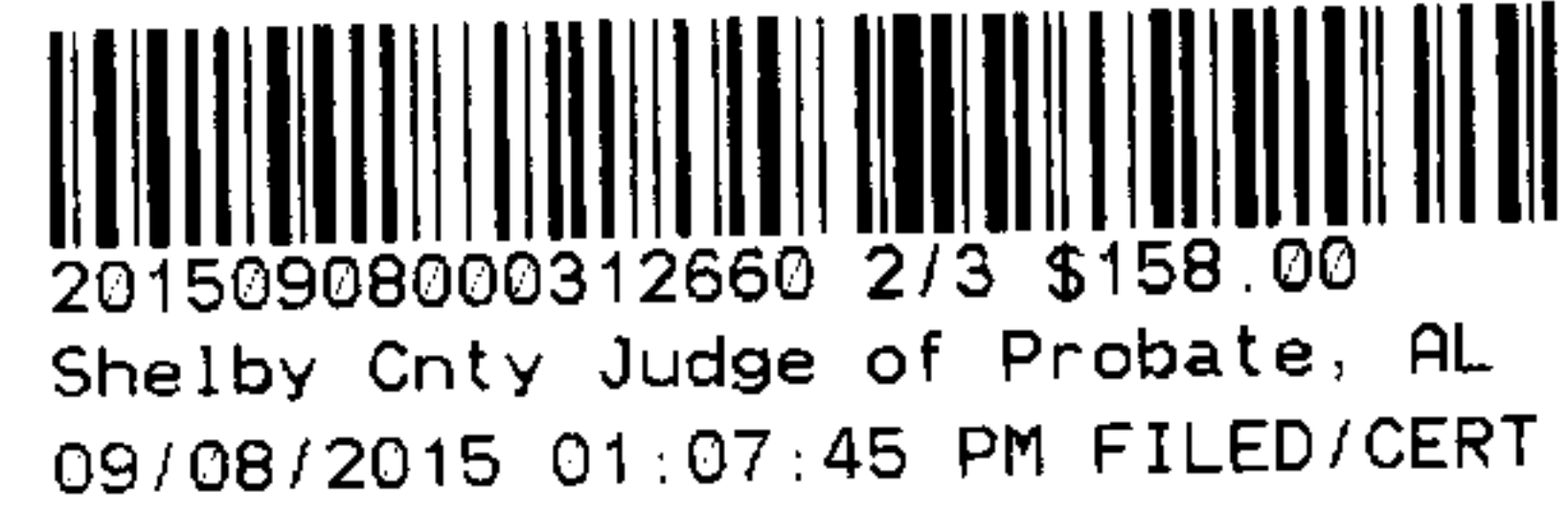
### *Registered Office; Registered Agent*

The cessation of membership of one or more members will not result in the dissolution of the Company.


