

AFFIDAVIT

Before me, the undersigned Notary Public in and for said state, personally appeared Jon D. Robinson, who is known to me and who upon being duly sworn on oath does depose and say as follows:

I, Jon D. Robinson, am a practicing lawyer in the State of Illinois. I practice as the senior partner of Bolen, Robinson Ellis, LLP at Decatur, Illinois. For the past several years, my firm and I have represented Nick G. Striglos, who is now deceased. As part of our work regarding the Estate of Nick G. Striglos I have been made aware of the following Deeds:

- A Special Warranty Deed from Christian Brothers Montgomery A, LP to Nick G. Striglos, Trustee of the Nick G. Striglos Revocable Inter Vivos Trust #2, dated January 18, 2012, filed in the office of the Judge of Probate of Montgomery County, Alabama, in Real Property Book 48, at Page 630; and
- A Special Warranty Deed from Christian Brothers Hoover, LP to Nick G. Striglos, Trustee of the Nick G. Striglos Revocable Inter Vivos Trust, dated December 1, 2011, filed in the office of the Judge of Probate of Shelby County, Alabama, as document number 20120124000028200.

I hereby certify that after diligently searching the files and records maintained by me and my firm (Bolen, Robinson Ellis, LLP) on behalf of our client Nick G. Striglos, I have been unable to find either of the Trust Agreements referenced above. Further, I have not found any record that such trusts ever existed, or any evidence that Nick G. Striglos requested that I draft any such Trust Agreements. After his death, I have discovered that on several occasions Nick G. Striglos directed property to be conveyed to trusts which he apparently intended to create only after he recorded the deed for the conveyance into trust. The trust referenced in the two deeds described above, to my knowledge, were never created.
