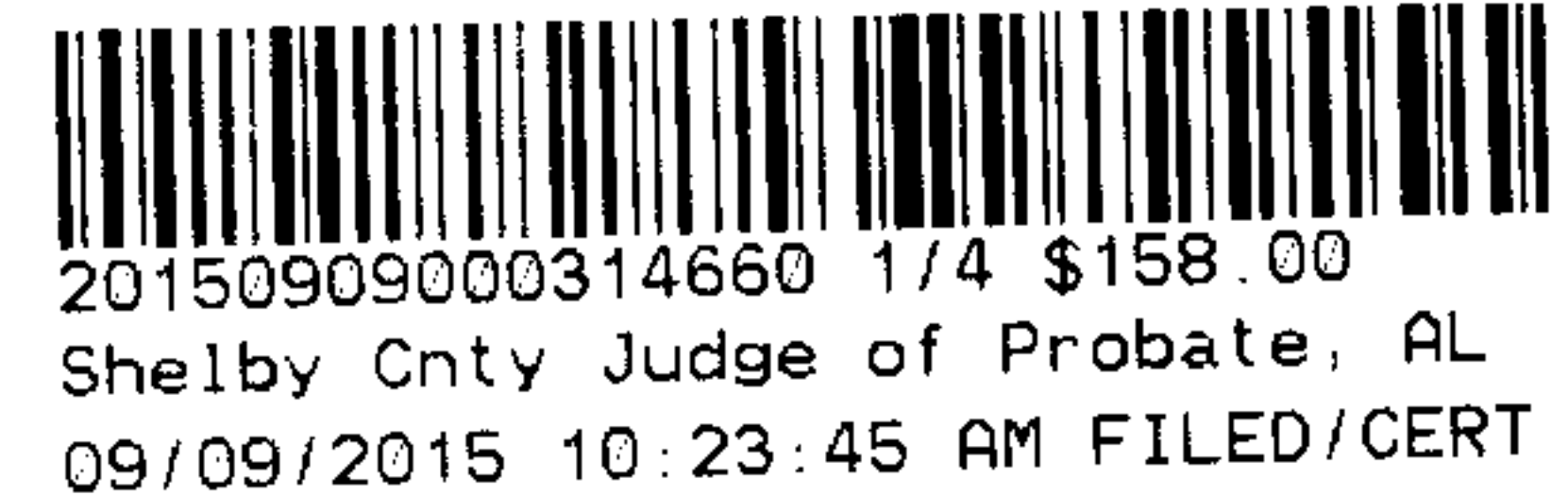

ARTICLES OF ORGANIZATION
OF
MARENO CONSTRUCTION, LLC



The undersigned, for the purpose of forming a limited liability company under Title 10A of the Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the Probate Judge of the county in which the initial registered office of the limited liability company will be located and affirm that the facts stated in these Articles of Organization are true and correct:

ARTICLE I

NAME OF COMPANY: The name of the limited liability company is **Mareno Construction, LLC**. ("The Company").

ARTICLE II

DURATION: The period of duration of the Company shall be from the date of filing of these Articles of Organization with the Office of the Probate Judge for Shelby County, Alabama until the first to occur of the following:

- (1) Fifty (50) years from the date of filing of these Articles of Organization; or
- (2) Dissolution of the Company pursuant to the provisions of the laws of the State of Alabama or the Operating Agreement of the Company, as in effect from time to time.

ARTICLE III

PURPOSES: The purpose for which the Company is organized is to perform any lawful purpose except that of banking and insurance.

ARTICLE IV

REGISTERED OFFICE AND AGENT FOR SERVICE OF PROCESS: The location and mailing address of the initial registered office of the Company shall be **100 Twin Brook lane, Bessemer, AL 35022**. The name of the initial registered agent for service of process at the foregoing address shall be **Brittany Mareno**.

ARTICLE V

INITIAL MEMBERS: The names and mailing addresses of the initial members of the Company are as follows:

ARTICLE VI

ADDITIONAL MEMBERS: Additional members may be admitted but only upon the unanimous written consent of the then existing members.

ARTICLE VII

CONTINUITY OF BUSINESS: Upon the death, retirement, resignation, expulsion, bankruptcy, dissolution, or dissociation of a member, or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall not be continued and the Company shall be dissolved unless there is obtained the written consent of all the remaining members of the Company within 90 day after the occurrence of the terminating event and there are at least two remaining members.

ARTICLE VIII

MANAGEMENT: A manager or managers shall manage The Company. The names and mailing address of the manager who is to serve as manager until the first annual meeting of the members or until said manager's successor is duly elected and qualified is follows:

ARTICLE XI

NO LIABILITY: The members of the Company shall have no liability for any debt, obligation, or liability of the Company, as provided in the Alabama Limited Liability Company Act.

ARTICLE X

PRINCIPAL PLACE OF BUSINESS: The principal place of business in the State of Alabama for the Company is **100 Twin Brook Lane, Bessemer, AL 35022**.

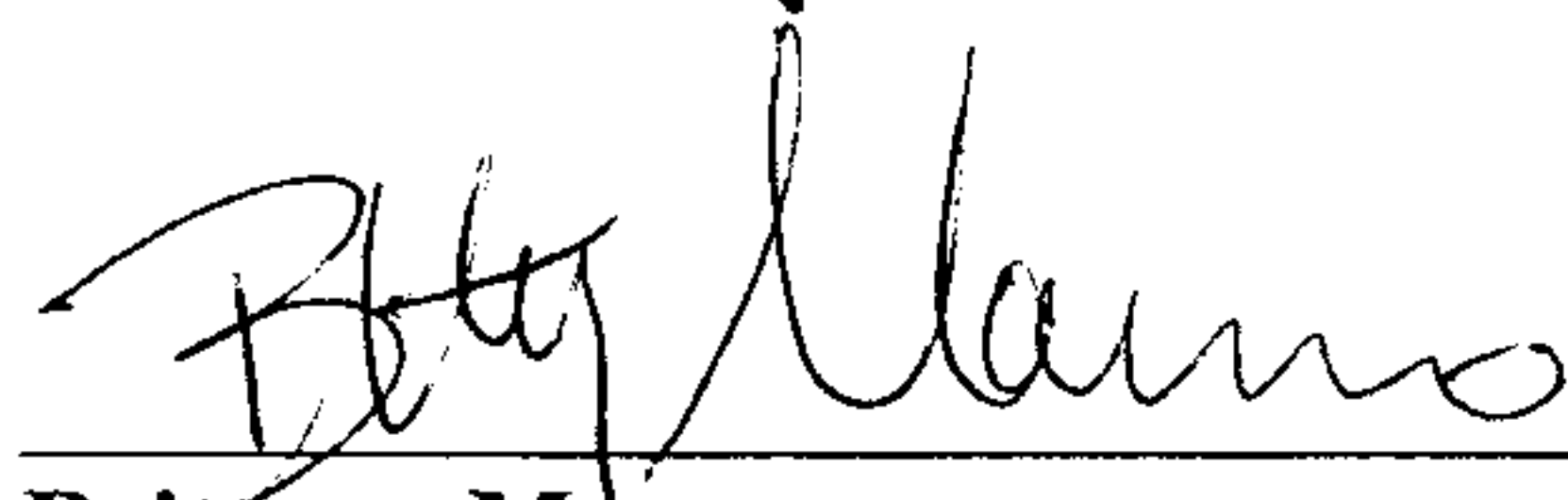
ARTICLE XI

ARTICLE XII

ADDITIONAL CONTRIBUTIONS: Additional contributions, if any, and the times at which, or the events of the happening of which, such additional contributions shall be made shall be as agreed to by the members of the Company in accordance with the Company's Operating Agreement.
