Know All Men by These Presents: That in consideration of **Three hundred two thousand four hundred fifty dollars and no/100 (\$302,450.00)**, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Donovan Builders, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Jeffrey D. Zisette and Elizabeth E. Zisette** following described real estate, situated in **Shelby County, Alabama**, to-wit:

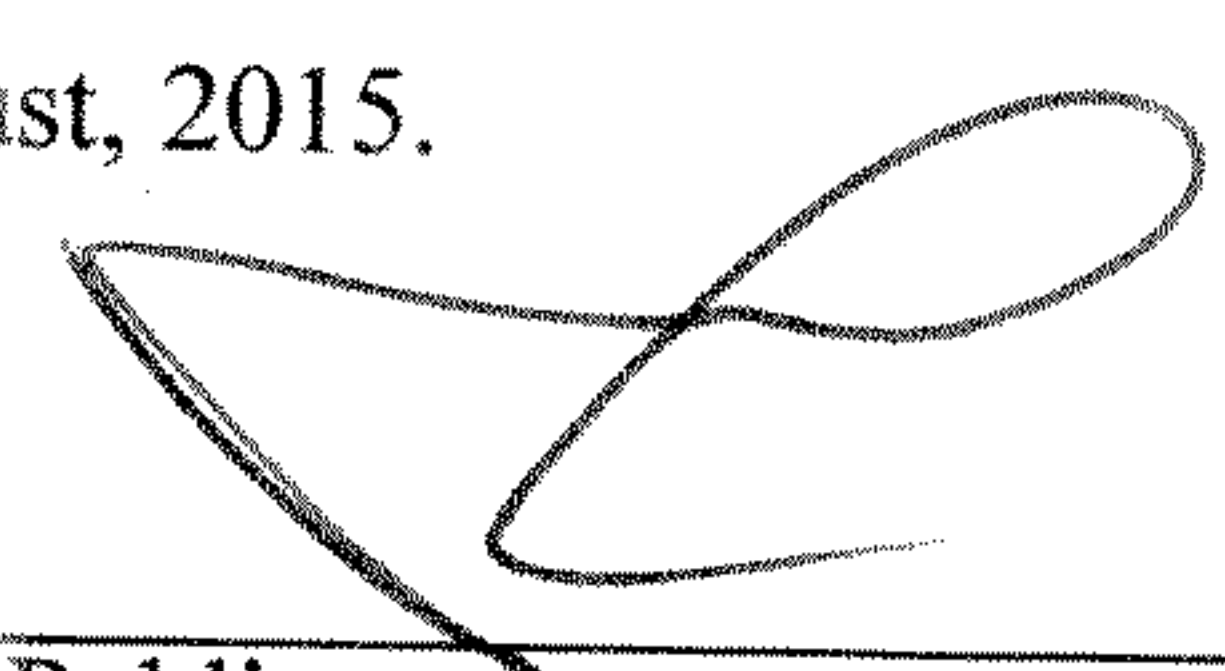

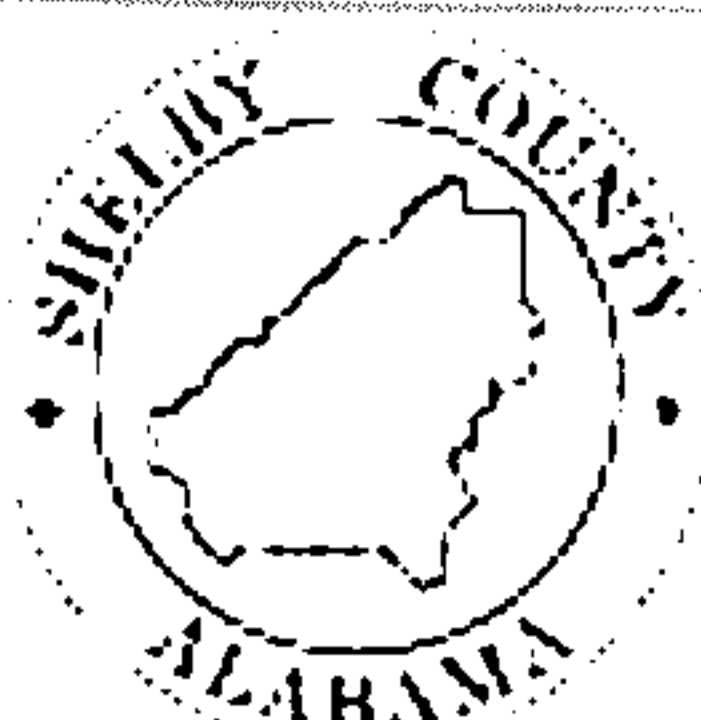
