KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One Hundred Seventy-Five Thousand And No/100 Dollars (\$175,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Phillip Henderson and wife, Michelle Henderson (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Paul W. Davis and Laura M. Davis (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

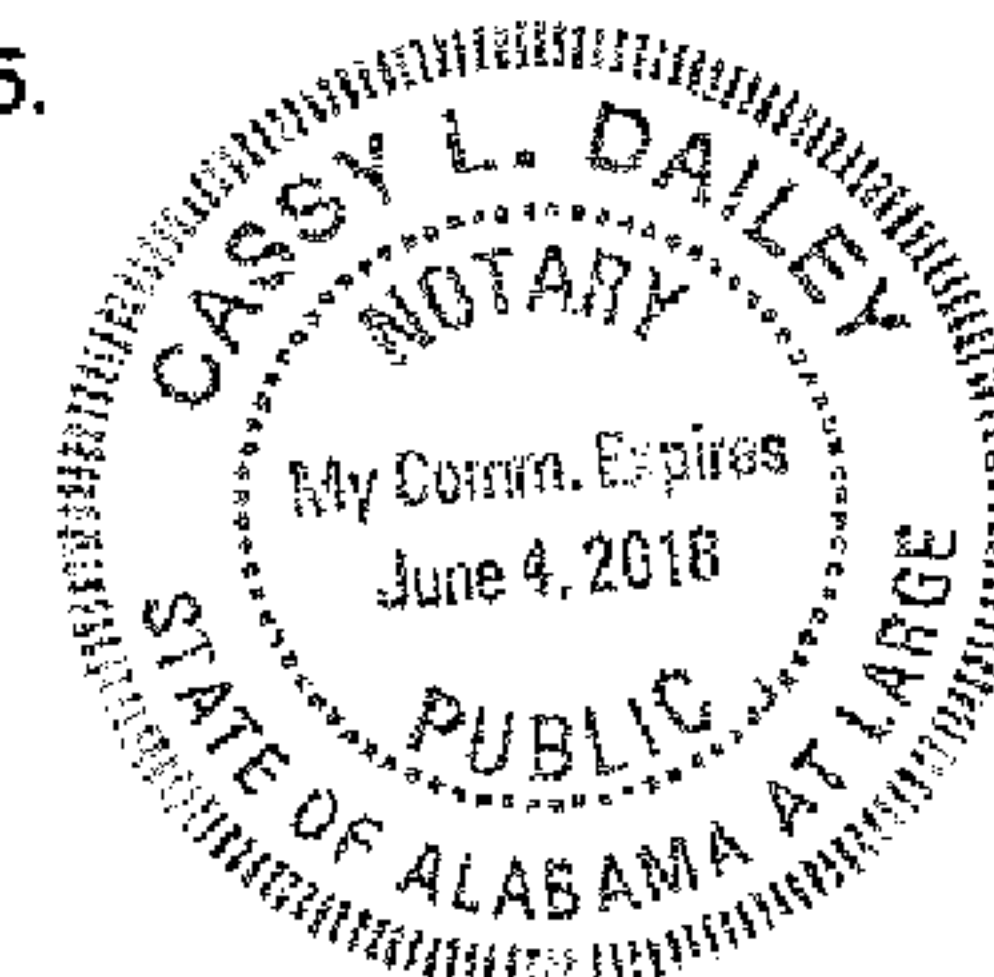

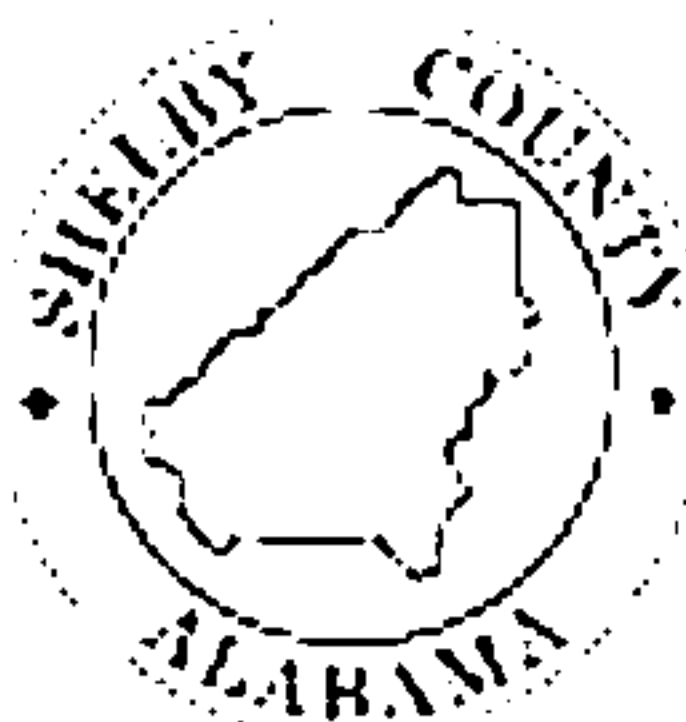
