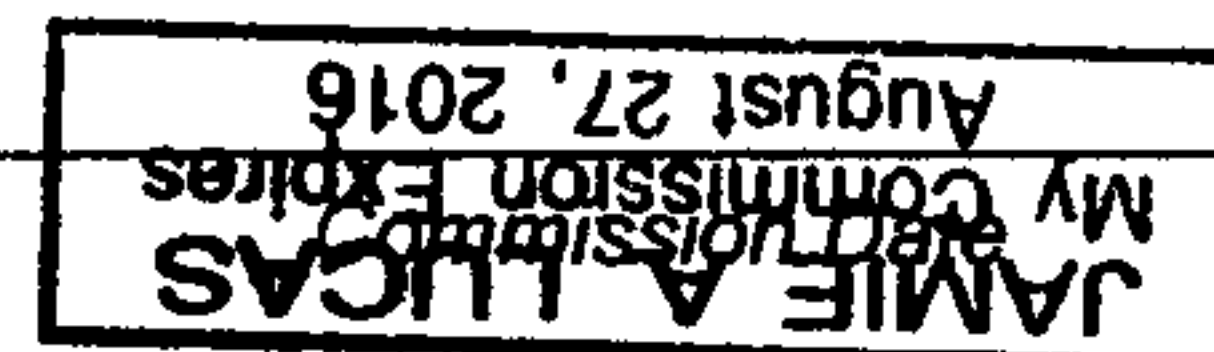
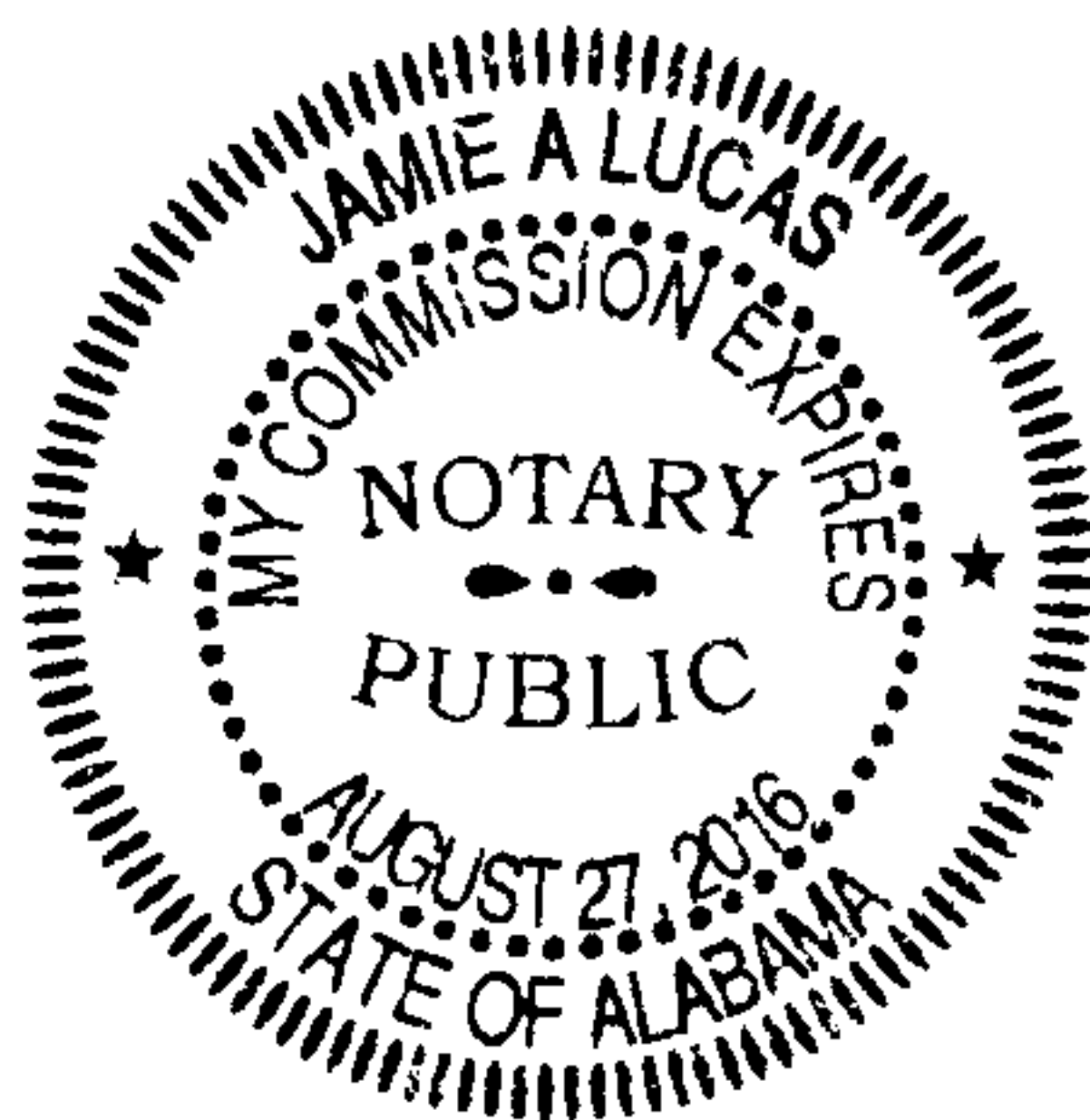

writings obligatory in the nature of a bond.

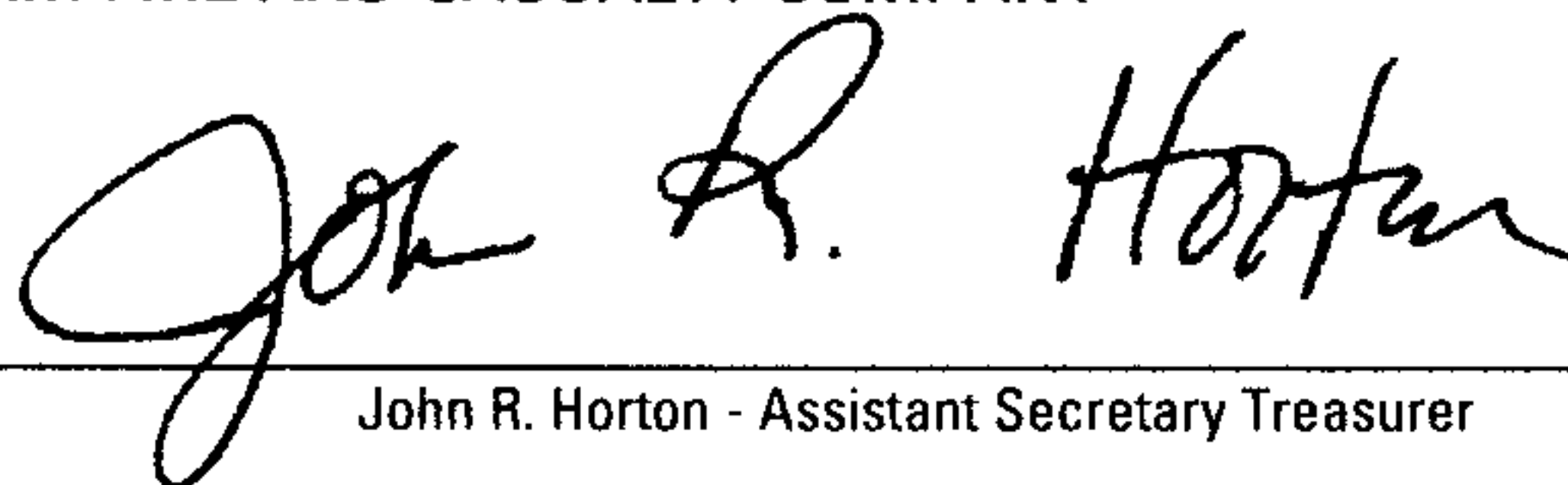
RESOLVED, that any Officer of the Company who works regularly with surety bonds is hereby authorized to appoint and empower any
