WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this September 11, 2015, That for and in consideration of **THREE HUNDRED TWENTY NINE THOUSAND NINE HUNDRED AND NO/100 (\$329,900.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **WILLIAM WINKS and PATSY WINKS**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **THOMAS B. MADDOX and ALICIA RENEE MADDOX**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 90, according to the Final Plat of Oaklyn Hills Phase 2, as recorded in Map Book 30, Page 17, in the Probate Office of Shelby County, Alabama.

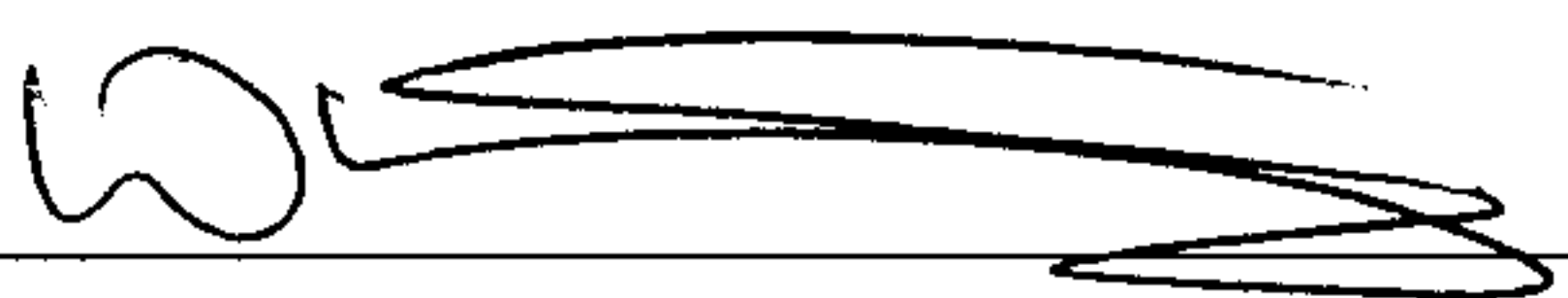

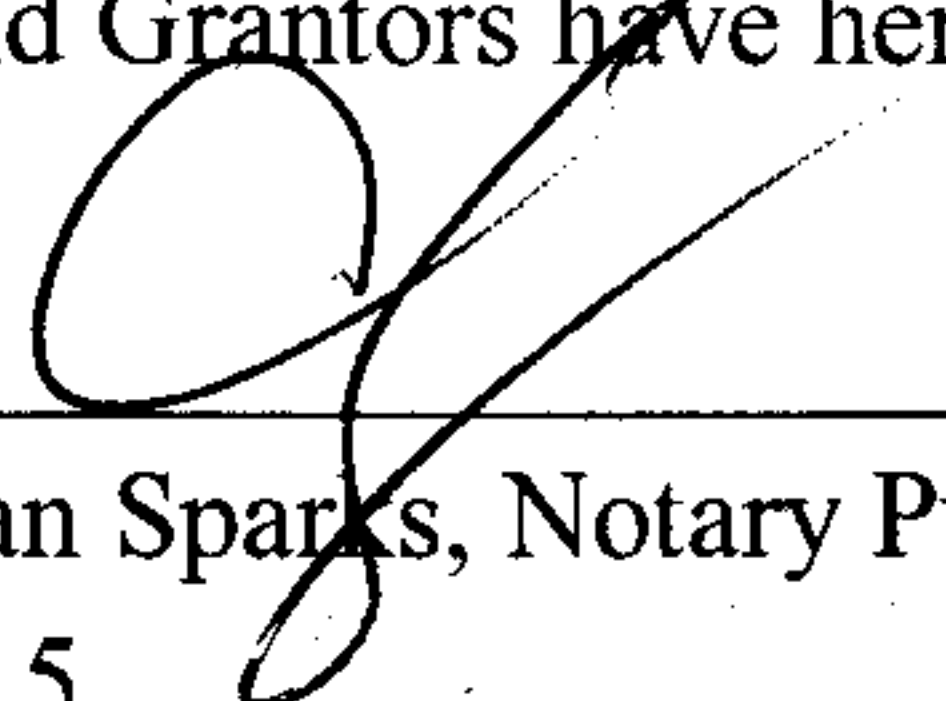
