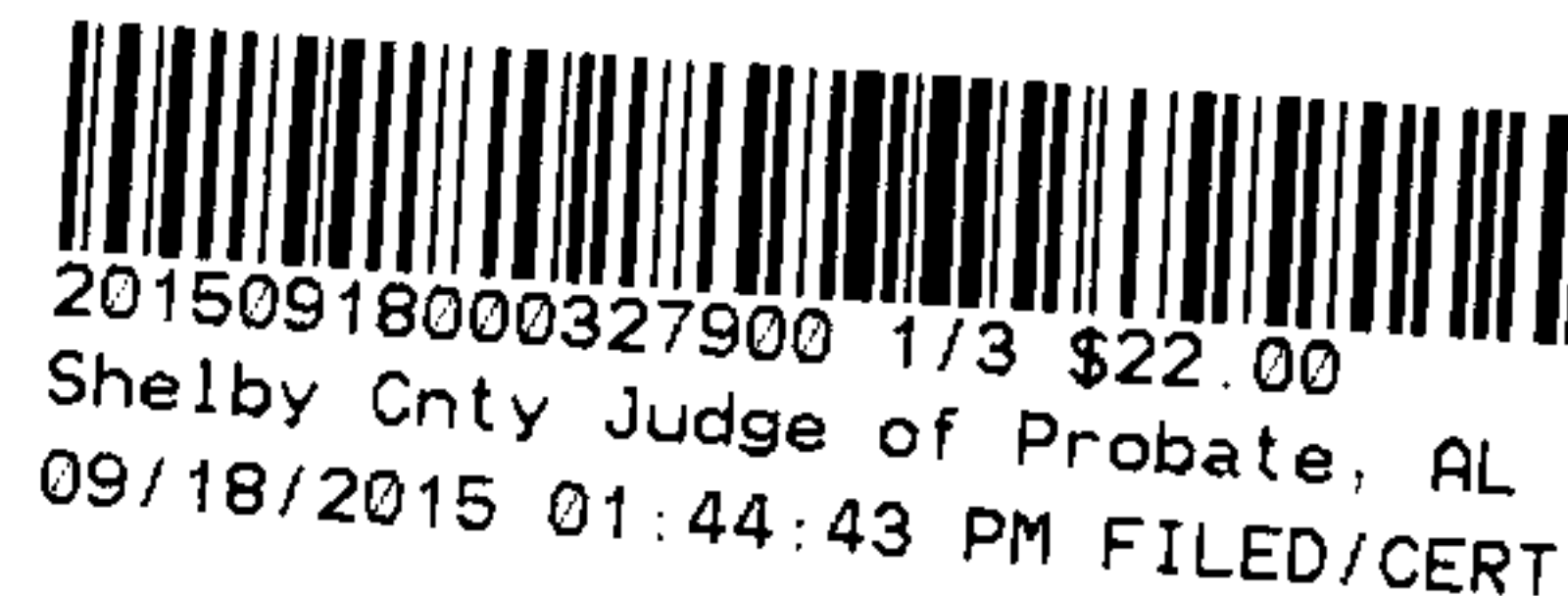

On this September 14, 2015, That for and in consideration of **NINETY SIX THOUSAND AND NO/100 (\$96,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **EMILY SYKES BENSON (WHO IS ONE AND THE SAME PERSON FORMERLY KNOWN AS EMILY SYKES as grantee recorded in that certain Instrument #20090602000209110) and JASON DANIEL BENSON, wife and husband**, (herein referred to as "Grantors"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the GRANTEE, **MORGAN E. 
