

**ARTICLES OF ORGANIZATION**  
**OF**  
**BKC ENTERPRISES, LLC**  
**A LIMITED LIABILITY COMPANY**  
**ORGANIZED UNDER THE LAWS OF ALABAMA**

The undersigned, acting as the organizers of a limited liability company under the Alabama Limited Liability Company Act (the “Act”), hereby adopt the following Articles of Organization for BKC ENTERPRISES, L.L.C. (hereinafter called the “Company”).

1. The name of the Company is BKC ENTERPRISES, L.L.C., Limited Liability Company (LLC).
2. The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act, or other applicable laws.
3. The purposes, objects and powers of the Company are:
  - a. To engage in any lawful business, act or activity for which a limited liability company may be organized under the laws of the State of Alabama.
  - b. Without limiting the scope and generality of the foregoing, to engage in the business of delivering and stocking goods and product in stores for wholesale and retail sales, and to engage in any business of any kind directly or indirectly related thereto.
  - c. To have and to exercise any and all the powers specifically granted in the Act, none of which shall be deemed to be inconsistent with the nature, character or the object of the Company and none of which are denied to it by these Articles of Organization.
4. The mailing address of the initial registered office is 514 Homestead Drive, Wilsonville, Alabama 35186, and the name of the initial registered agent of the Company at such address is Brian Carroll.
