WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of the sum of **One Hundred Twenty Four Thousand Dollars and No Cents (\$124,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor or Grantors in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **William Drake Roberts and Christine P. Roberts, husband and wife, whose mailing address is 300 Linden Street, Trussville, AL 35173** (herein referred to as Grantors), do grant, bargain, sell and convey unto **Ian Walker and Lauren Walker, husband and wife, whose mailing address is 1631 Highway 47, Columbiana, AL 35051** (herein referred to as Grantees), for and during their joint lives as tenants and upon the death of either of them then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby, County, Alabama, **the address of which is 402 Timothy Drive, Columbiana, AL 35051**; to wit;

LOT NO. 12, ACCORDING TO THE SURVEY OF TRIPLE SPRINGS SUBDIVISION, AS RECORDED IN MAP BOOK 5, PAGE 34, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.

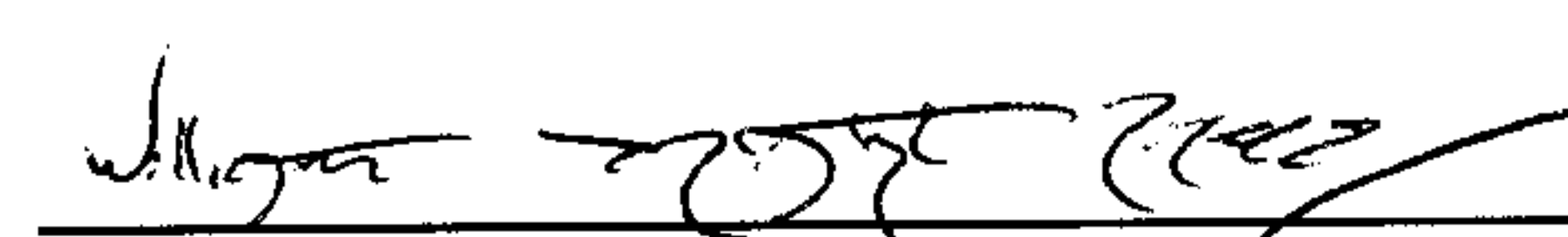

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said Grantees, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.

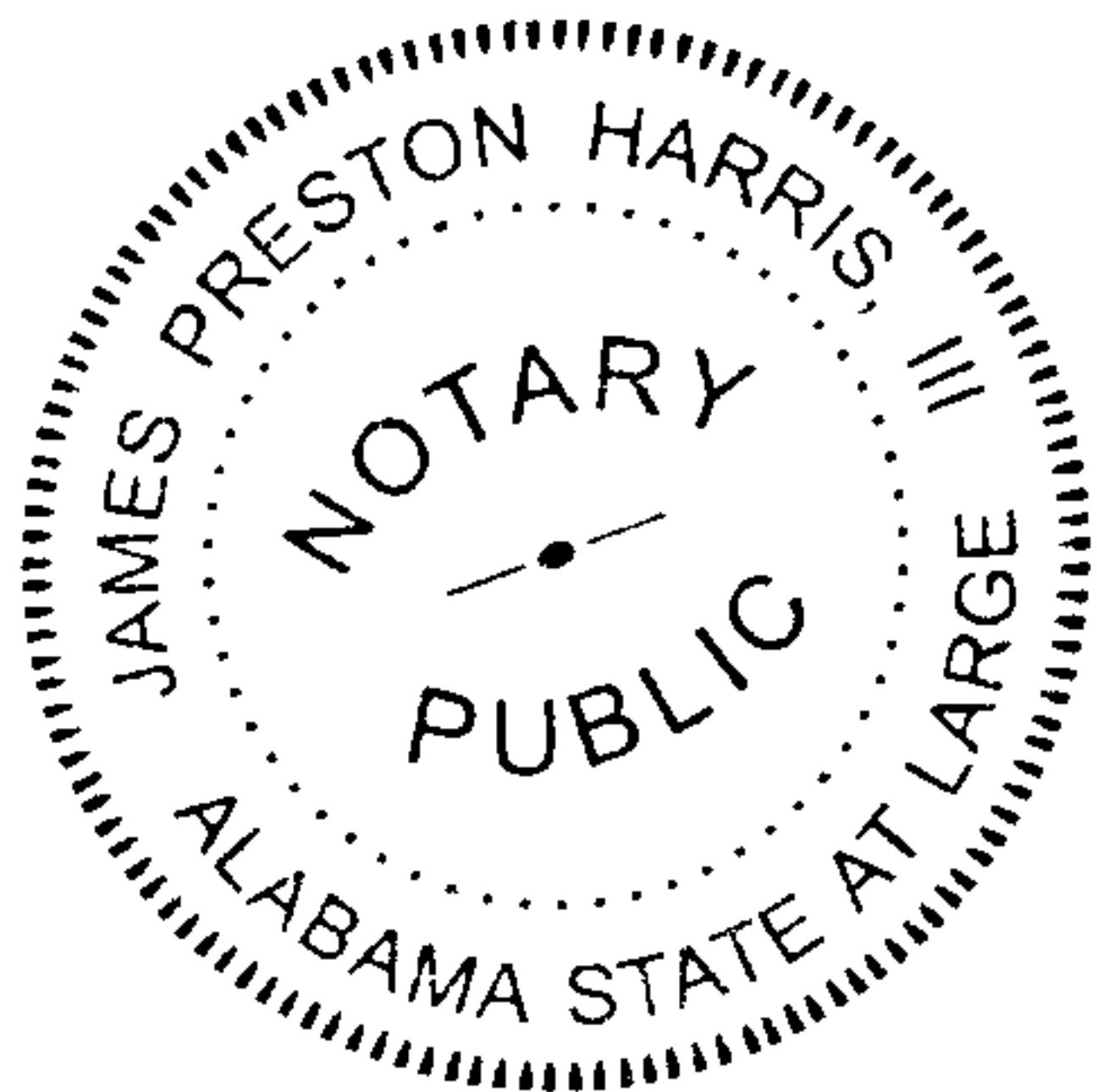
