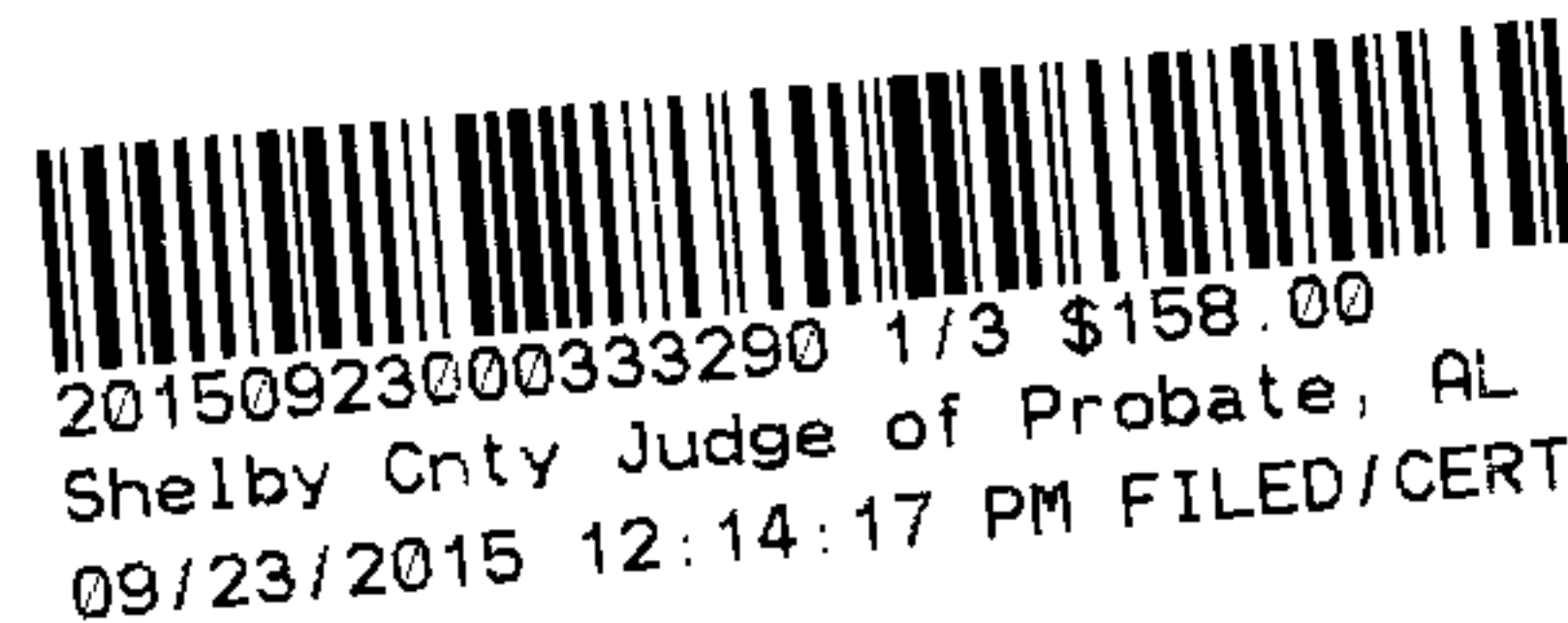

CERTIFICATE OF FORMATION
OF

The undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certifies as follows:

1. The entity shall be a limited liability company.
2. The name of the limited liability company is Curles Properties, LLC.
3. The existence of the limited liability company shall commence on the date of the filing of this Certificate of Formation in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
