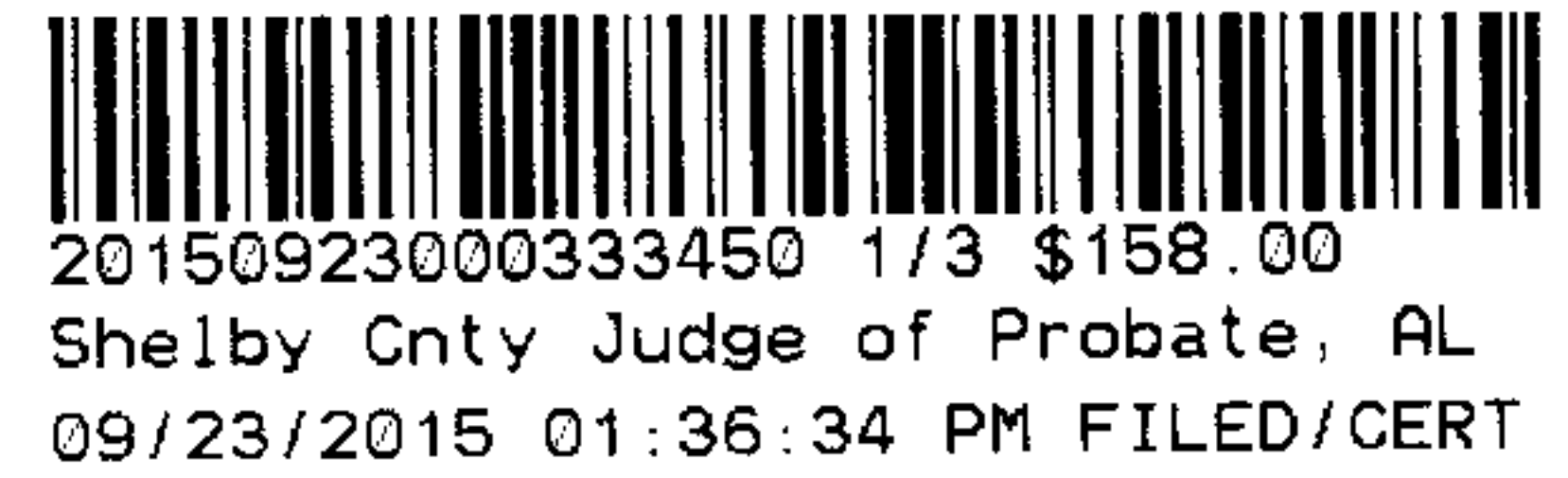


**CERTIFICATE OF FORMATION

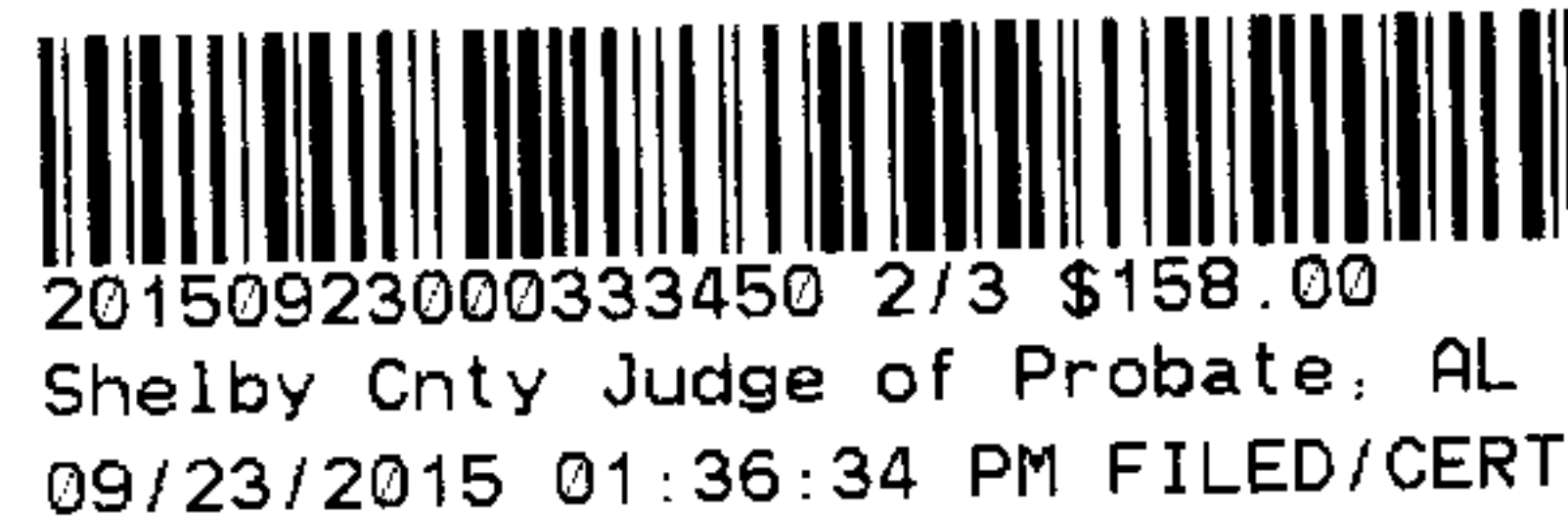
**ARTICLE FIVE**

The Company has at least one member.


