KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of FOUR THOUSAND TWO HUNDRED NINETY AND NO/100 DOLLARS (\$4,290.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantor, **PROPST FULTONDALE, LLC**, a Delaware limited liability company, by **PROPST PROPERTIES**, a Delaware limited liability company and sole member, by **JOHN N. HUGHEY**, Managing Member (hereinafter referred to as Grantor), the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **DONNIE HAMFF** and **CHARLOTTE HAMFF** (hereinafter referred to as Grantee), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:



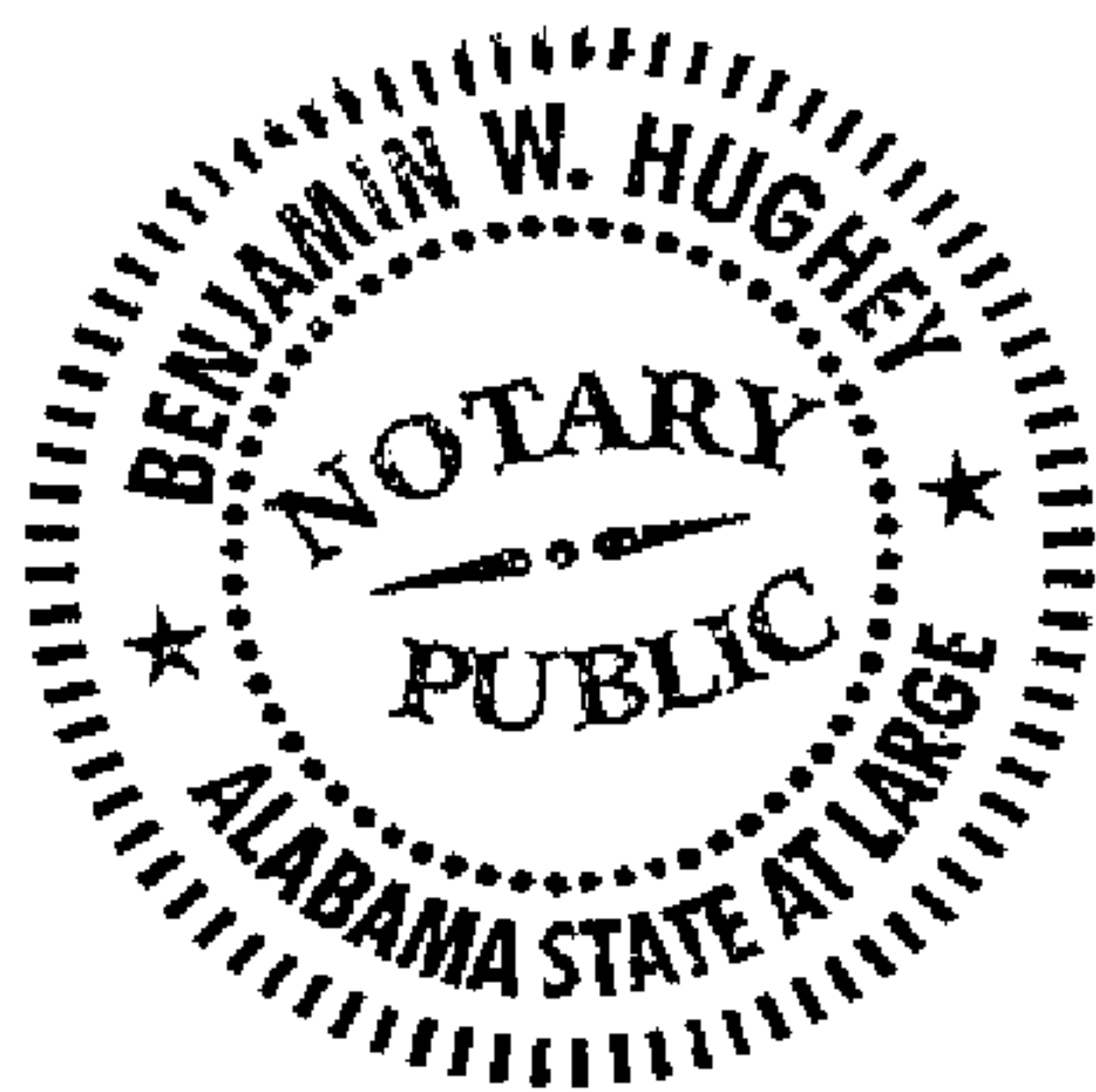
