KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of December, 2005, William E. Traywick, a married man and Penny M. Traywick, his wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as a nominee for Pinnacle Financial Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20051222000660660; having been corrected & re-recorded in Instrument Number 20061011000503700, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, National Association, by instrument recorded in Instrument No. 20120405000117760, in the aforesaid Probate Office ("Transferee"); and

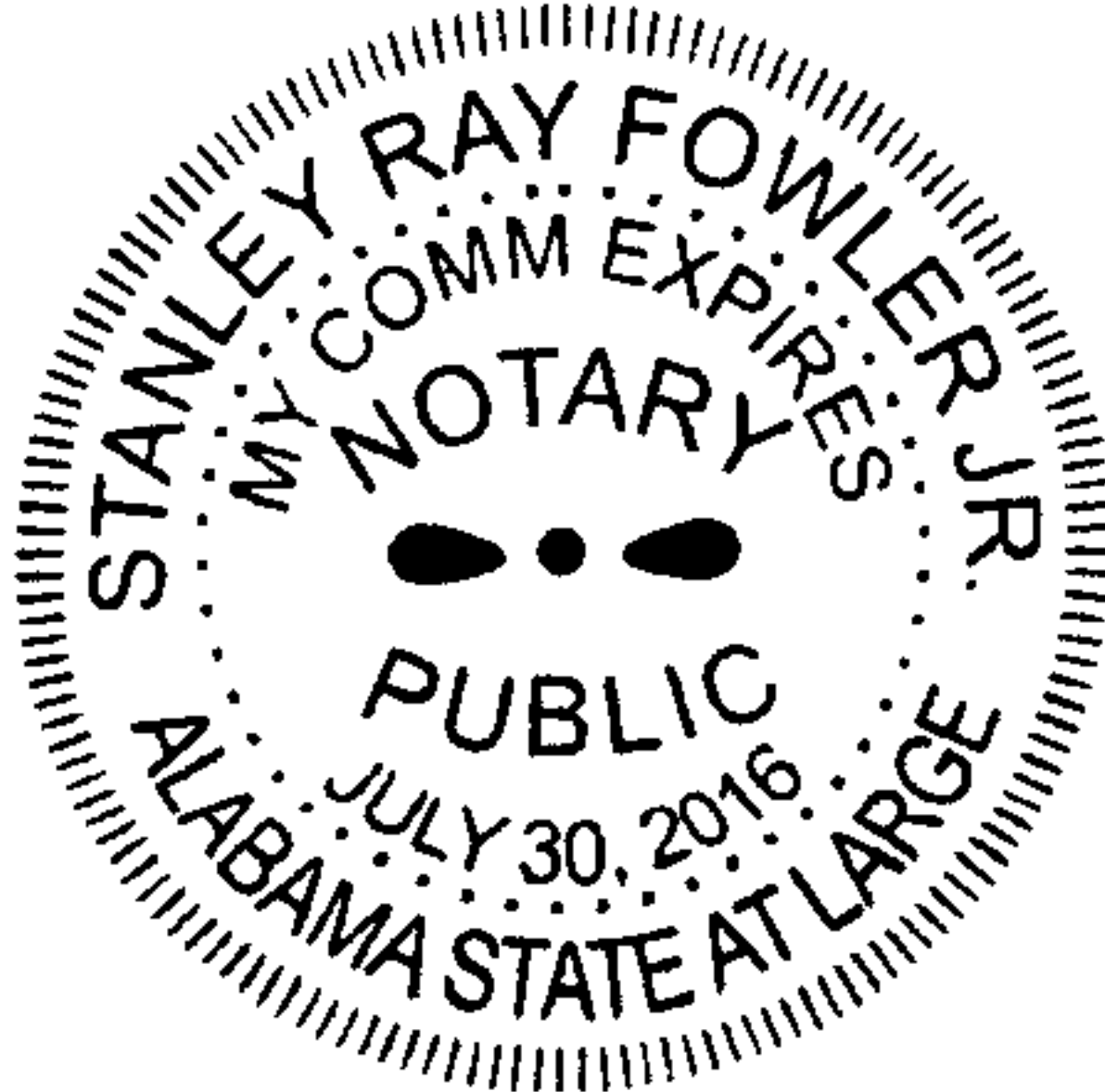

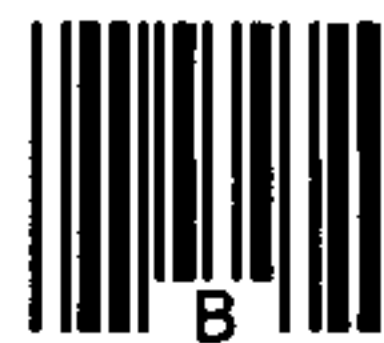


