
Beginning at the southeast corner of SE 1/4 of SW 1/4, Section 20, Township 19 South, Range 2 East, go North 1320 feet to southeast corner of NE 1/4 of SW 1/4 of Section 20, Township 19 South, Range 2 East; thence 87 degrees 13 minutes left 462.9 feet; thence 90 degrees right 618.1 feet to the North boundary of the right of way of Shelby County Highway No. 62 and the point of beginning of the land herein described; thence 22 feet North; thence 93 degrees 02 minutes left 381 feet to a point; thence South 158 feet to the North boundary of said highway right of way to the point of beginning; located in the NE 1/4 of SW 1/4, Section 20, Township 19 South, Range 2 East, Shelby County, Alabama.

This Power of Attorney shall not be affected by disability, incompetence, or incapacity of the principal **Samantha A. Vick**, it being the intent of the principal to form a Specific Durable power of attorney.

This document hereby expressly revokes any previous Power of Attorney executed by me, regardless of requirements or revocation contained therein.
