

ARTICLES OF ORGANIZATION
OF
SOUTHERN ARMOR APPAREL, LLC

For the purpose of forming and establishing a limited liability company under the laws of the State of Alabama and pursuant to the provisions of the Alabama Limited Liability Company Act (Code of Alabama 1975, Sections 10-12-1 through 10-12-61) and all amendments thereto, the undersigned certify as follows:

1. The name of the limited liability company is Southern Armor Apparel, LLC.
2. The existence of the limited liability company shall begin on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, AL and shall continue until such time as one of the following may occur:
 - (a) Upon the written consent of the member(s);
 - (b) As provided in the Operating Agreement; or
 - (c) As may be required by the Alabama Limited Liability Act.
3. The limited liability company is organized for profit and the nature of its business or purposes to be conducted or promoted is:
 - (a) To purchase and sell automotive vehicles on a wholesale and retail basis;
 - (b) To engage in any lawful act or activities for which companies may be organized under the Alabama Limited Liability Company Act.
4. The location and mailing address of the initial registered office of the limited liability company shall be 9100 Highway 11, Chelsea, AL 35043. The name of the initial registered agent shall be Anthony J. King.
5. The limited liability company shall be managed by its member(s). The name(s) and mailing address(es) of the member(s) of the limited liability company are as follows:

6. The member(s) of the limited liability company shall have the right to commit additional member(s) to the limited liability company upon the unanimous written consent of all of the existing member(s).

The member(s) of the limited liability company shall dissolve the business of the limited liability company on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that terminates the continued member(s) in the limited liability company, unless member(s) consents to the continuation of the business of the limited liability company within sixty (60) days of the occurrence of any event which would otherwise terminate the existence of the limited liability company.
8. The total amount of contributions to the capital of the limited liability company is Five Hundred Dollars (\$500.00).
9. The Operating Agreement of the limited liability company may from time to time be repelled, amended or altered or a new Operating Agreement may be adopted by the member(s).
10. The member(s) of the limited liability company shall not be liable under a judgment, decree or order of court or in any other matter for a debt, obligation or liability of the limited liability company.
