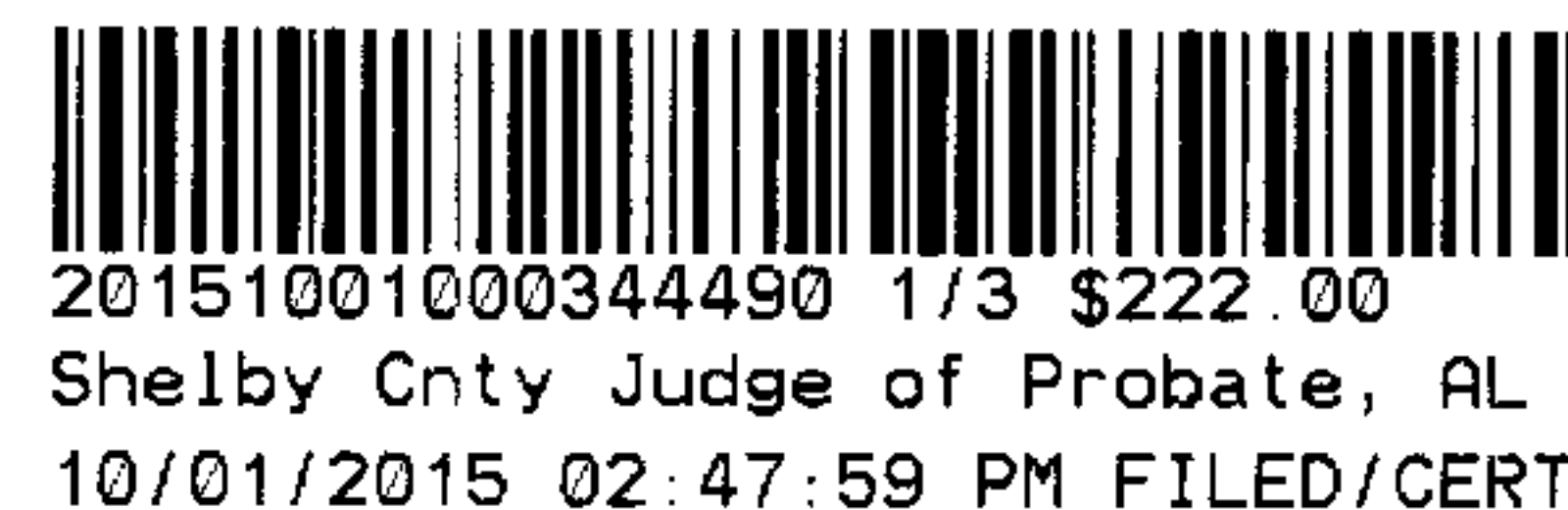

WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA
COUNTY OF SHELBY**

KNOW ALL MEN BY THESE PRESENTS,

On this September 28, 2015, That for and in consideration of **TWO HUNDRED TWO THOUSAND AND NO/100 (\$202,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **HAROLD O. MCDONALD, JR., a married man, and CHERI L. WATKINS, a married woman**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **MICHAEL CRAFT and KIRA G. CRAFT**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 1-B, Block 1, Resurvey and Subdivision of Lot 1A, Block 1, according to a resurvey of Stoneridge (Map Book 7, Page 153), and a Resurvey of Lot 6A Block 2 according to a Resurvey of Stoneridge (Map Book 7, Page 13), also a Resurvey of Lots 1, 2, 3, 4, and 5 Block 2 according to the Map of Stoneridge (Map Book 6, Page 153) as recorded in Map Book 8, Page 2, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to:

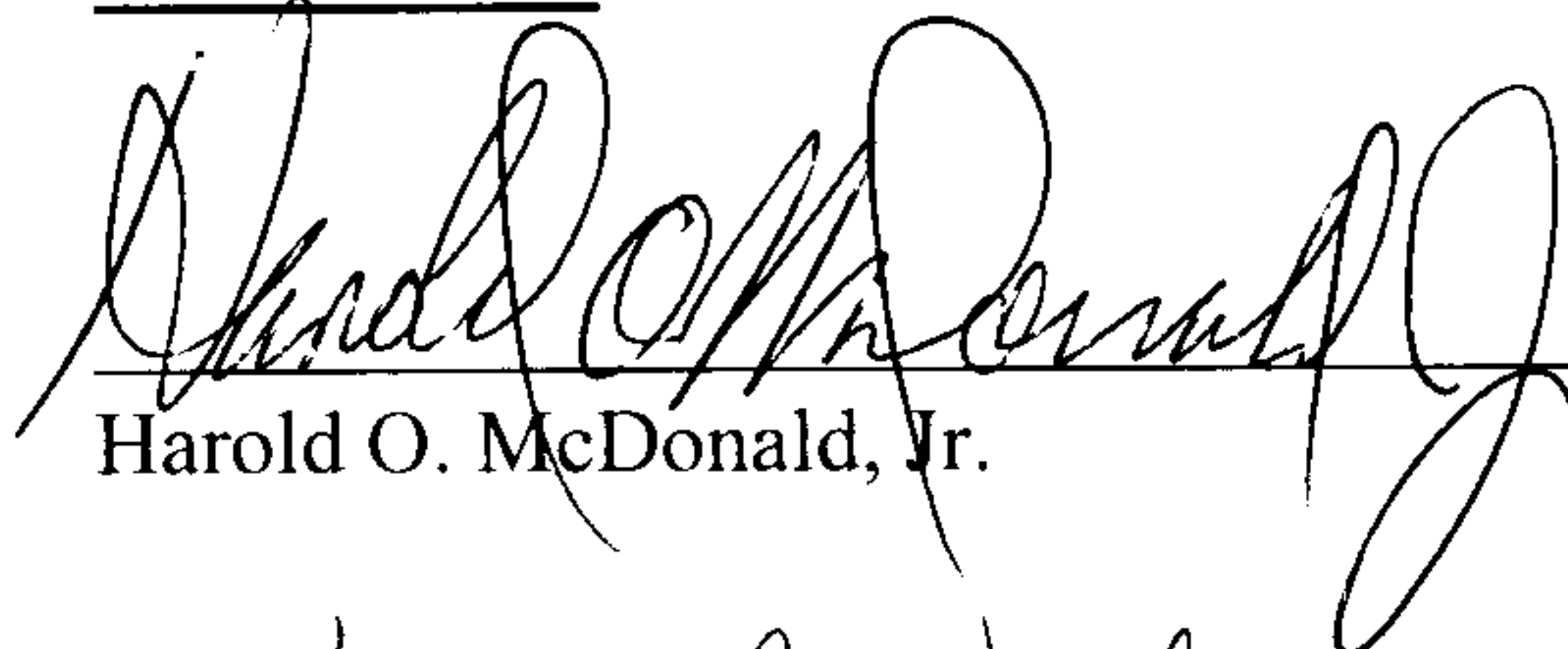

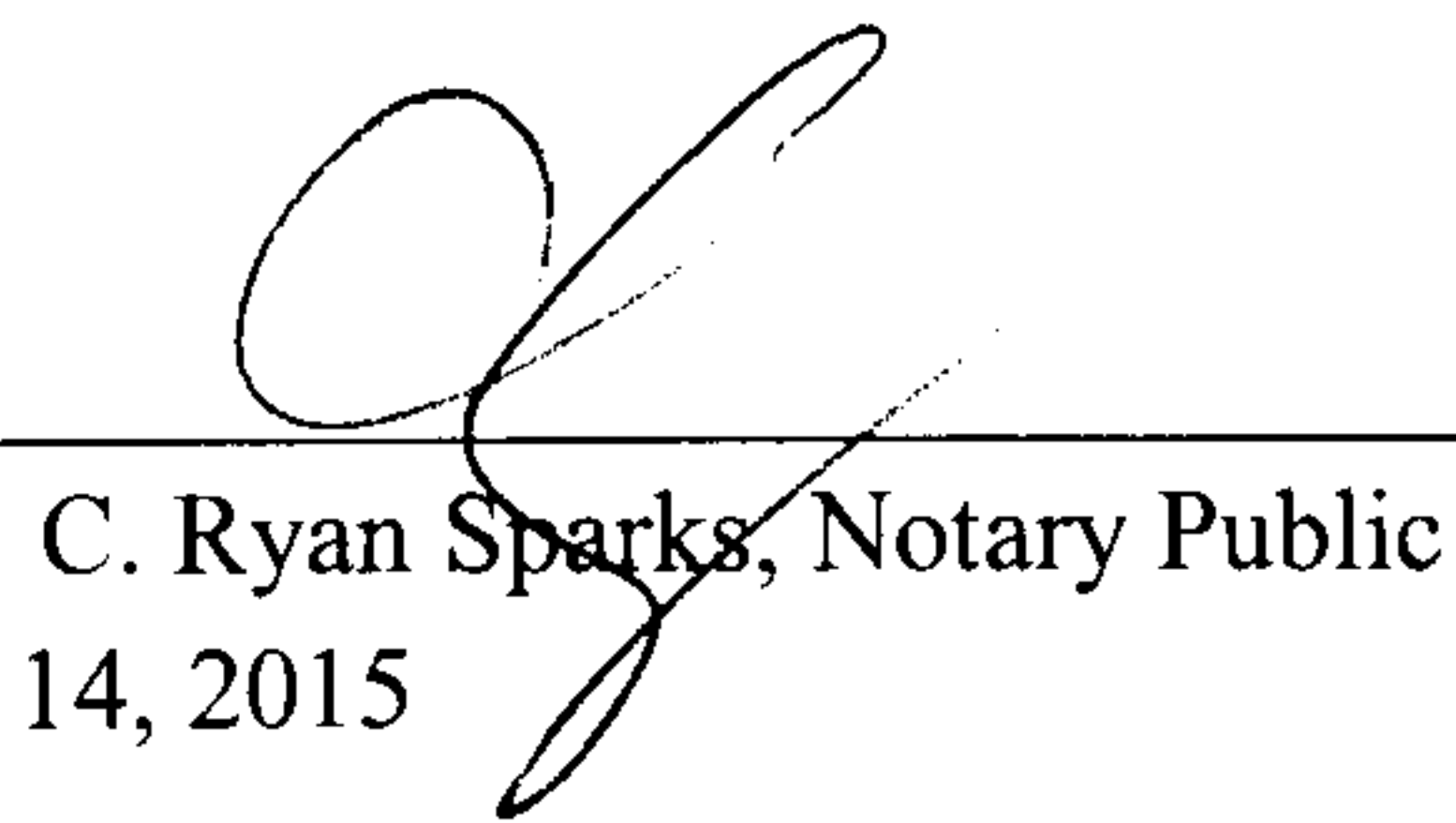

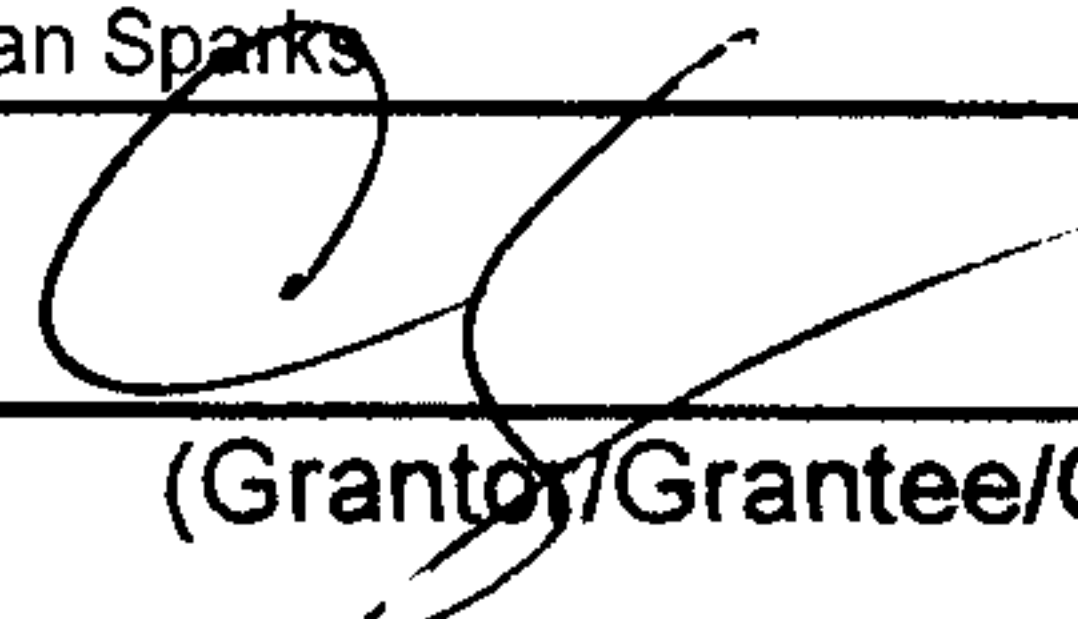
