

## ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION

OF

## COAL YARD ENTERTAINMENT, LLC

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:
