ASSIGNMENT AND ASSUMPTION OF GROUND LEASE

(Shelby Baptist Medical Center – HCP Shelby MOB, LLC)

This ASSIGNMENT AND ASSUMPTION OF GROUND LEASE (this "Assignment") is made and entered into as of the Effective Time on October 2, 2015, by and between **BAPTIST HEALTH SYSTEM**, **INC.**, an Alabama nonprofit corporation ("Assignor"), and **BBH SBMC**, **LLC**, a Delaware limited liability company ("Assignee").

- A. The Agreement requires that Assignor transfer to Assignee the Assumed Lease listed on Exhibit A hereto, and that Assignee assume Assignor's rights and obligations under the Assumed Lease to which Assignor is a party; and
- B. Effective simultaneously with the consummation of the transactions described in the Agreement, Assignor desires to assign the Assumed Lease to Assignee. - This Assignment is entered into pursuant to and in accordance with the terms and conditions of the Agreement. In the event of any conflict or inconsistency between the terms of the Agreement and the terms of this Assignment, the terms of the Agreement shall govern and control. All capitalized terms used but not expressly defined herein shall have the meanings given to them in the Agreement.


