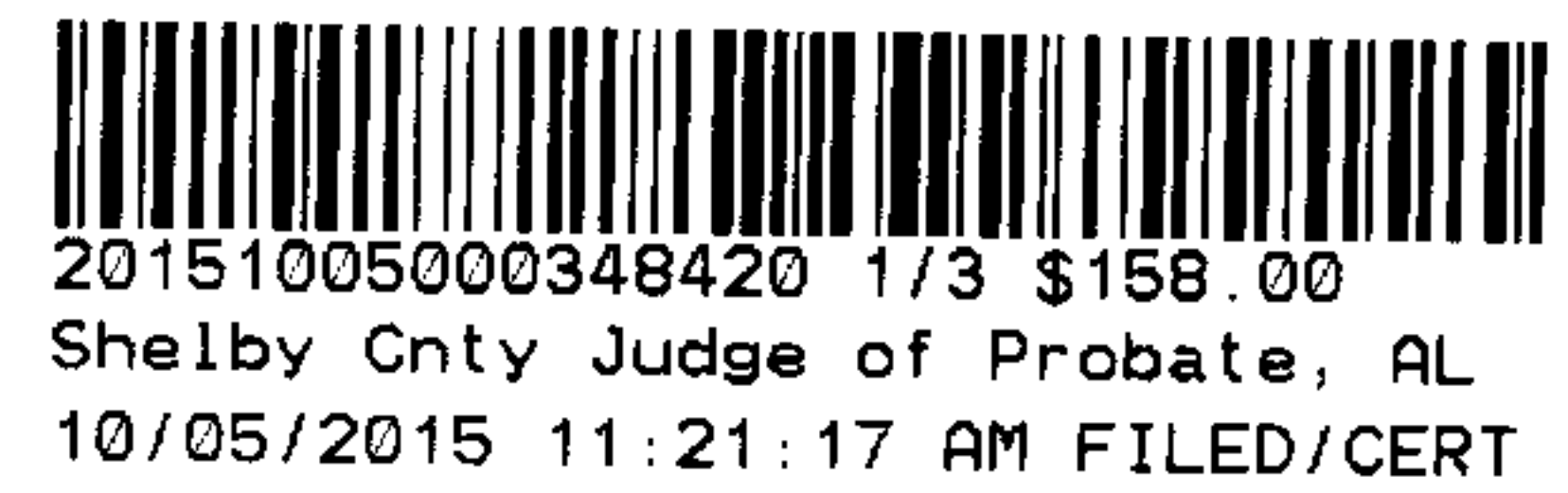

ARTICLES OF ORGANIZATION
OF

We, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1. The name of the Limited Liability Company is Ronquillo Drywall, LLC.
2. The existence of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Madison County, Alabama, and its duration shall be perpetual; provided, however, that the Limited Liability Company be dissolved (a) upon the written consent of all the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
3. The purpose for which this Limited Liability Company is organized is to engage in the business of providing construction services or any other lawful business for which Limited Liability Companies may be organized under the laws of the State of Alabama.

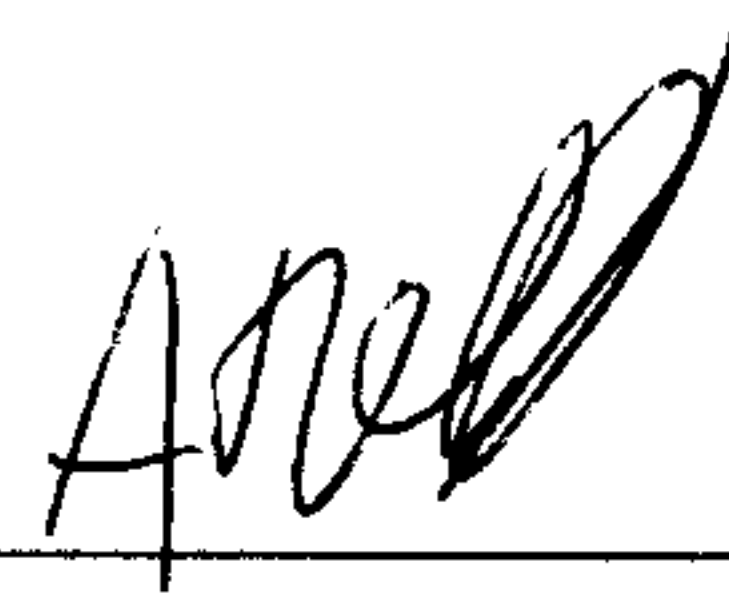

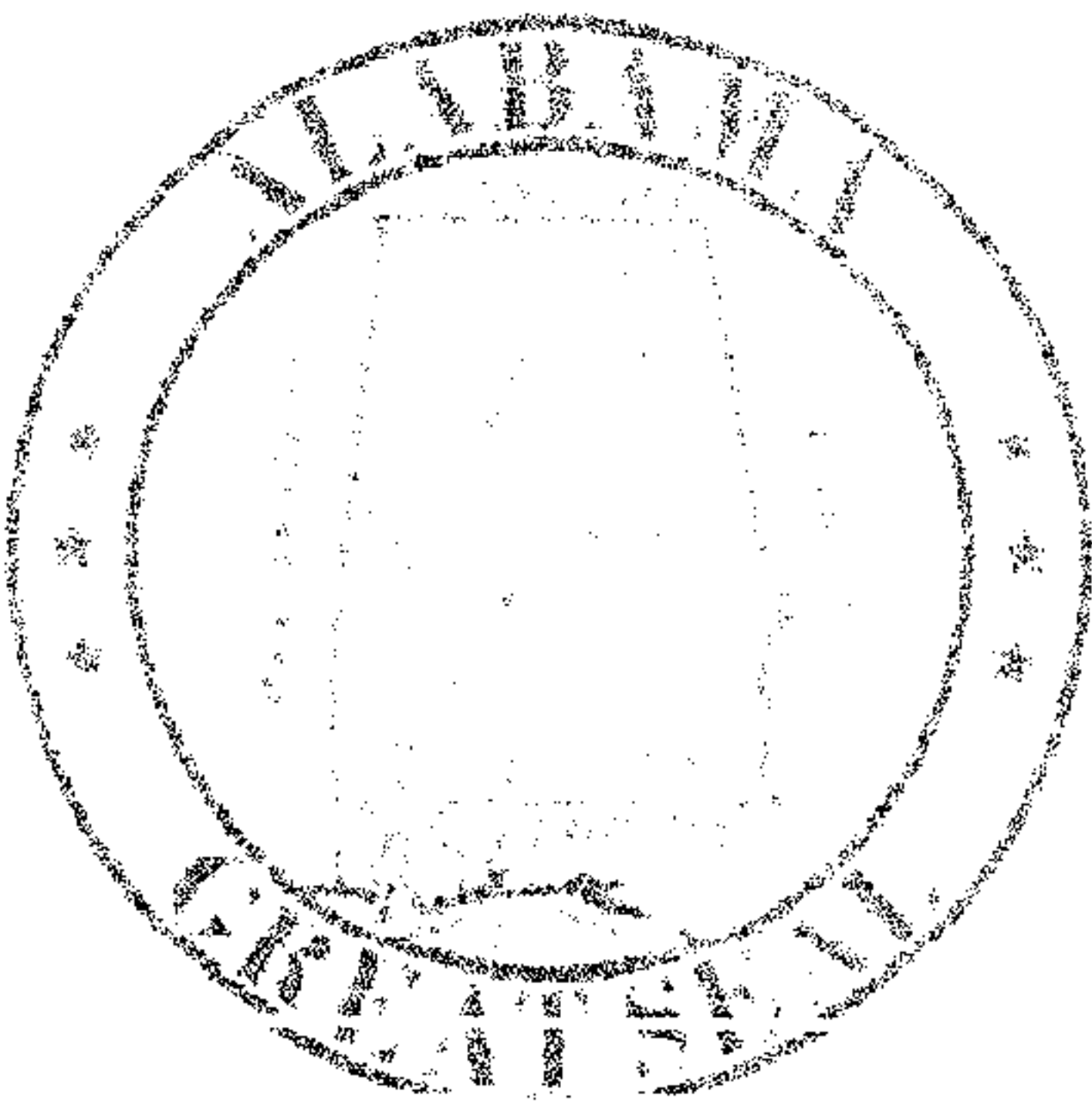
