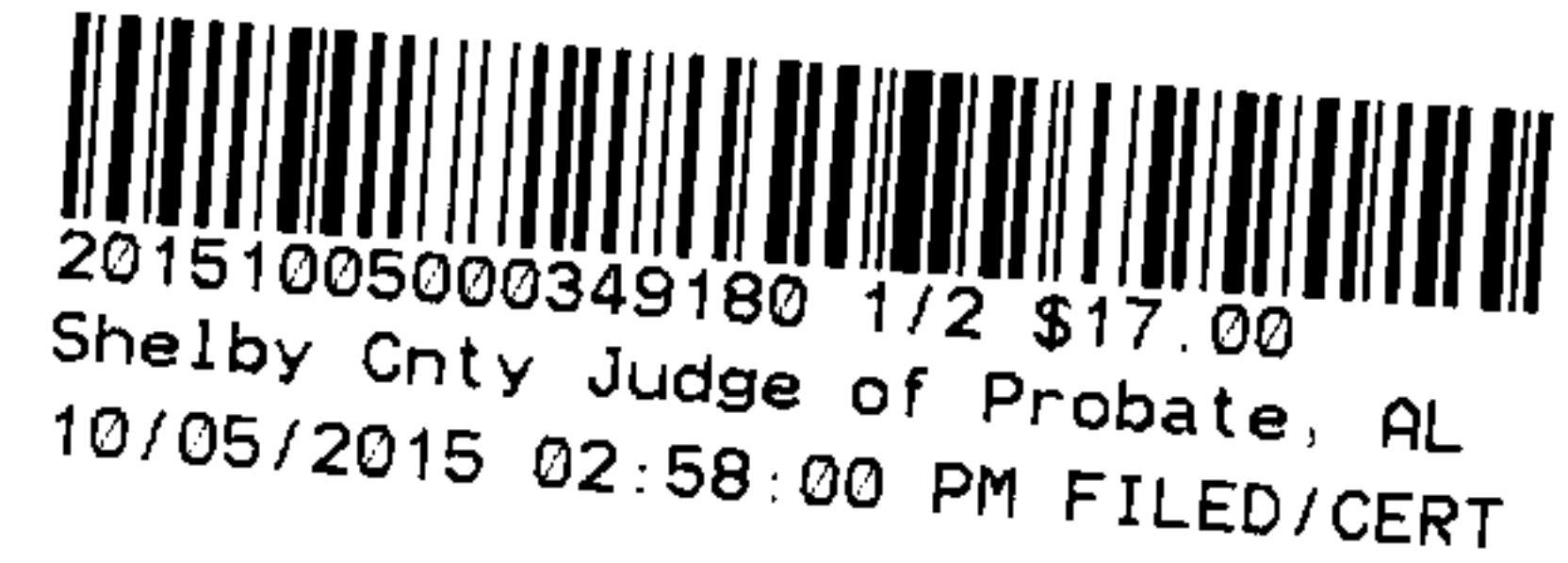

Certificate of Trust

The undersigned Trustors and Trustees hereby certify the following:

1. This Certificate of Trust refers to the **ROBERTS FAMILY TRUST DATED JULY 2, 2013 (THE TRUST)** and any amendments thereto, executed by **EUGENE EDWARD ROBERTS, JR. AS SETTLOR AND TRUSTEE AND BY EUGENE EDWARD ROBERTS, III, AS TRUSTEE**
2. The Settlor is **EUGENE EDWARD ROBERTS, JR, DECEASED**
3. Presently, the sole Trustee of the Trust (the "Trustee") is:

EUGENE EDWARD ROBERTS, III, (The former co-trustee EUGENE EDWARD ROBERTS, JR, having died on September 13, 2014). (Article Two of the Trust provides that if any of the initial Trustees fail to serve, the remaining initial Trustee will continue to serve, without the necessity of a successor Trustee.)
5. The Trustees are authorized to acquire, sell, convey, encumber, lease, borrow, manage and otherwise deal with interests in real and personal property in our Trust name.
6. The Trust is an **irrevocable** trust. Any person holding the power of revocation is named below: **NOT APPLICABLE.**
7. The Trust has the power and ability to hold title to Real Property. Prior to the death of the **former co-trustee EUGENE EDWARD ROBERTS, JR, on September 13, 2014** Title to Trust property was taken as **EUGENE EDWARD ROBERTS, JR. AND EUGENE EDWARD ROBERTS, III, AS TRUSTEES OF THE ROBERTS FAMILY TRUST DATED JULY 2, 2013.** Currently title to Trust Property may be taken as **EUGENE EDWARD ROBERTS, III, AS TRUSTEE OF THE ROBERTS FAMILY TRUST DATED JULY 2, 2013.**
8. The Trust has not been revoked and there have been no amendments limiting the powers of the Trustees over trust property.
9. No person or entity paying money to or delivering property to the Trustees shall be required to see to its application. All persons relying on this document regarding the Trustees and their powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A copy of this Affidavit of Trust shall be just as valid as the original.
