

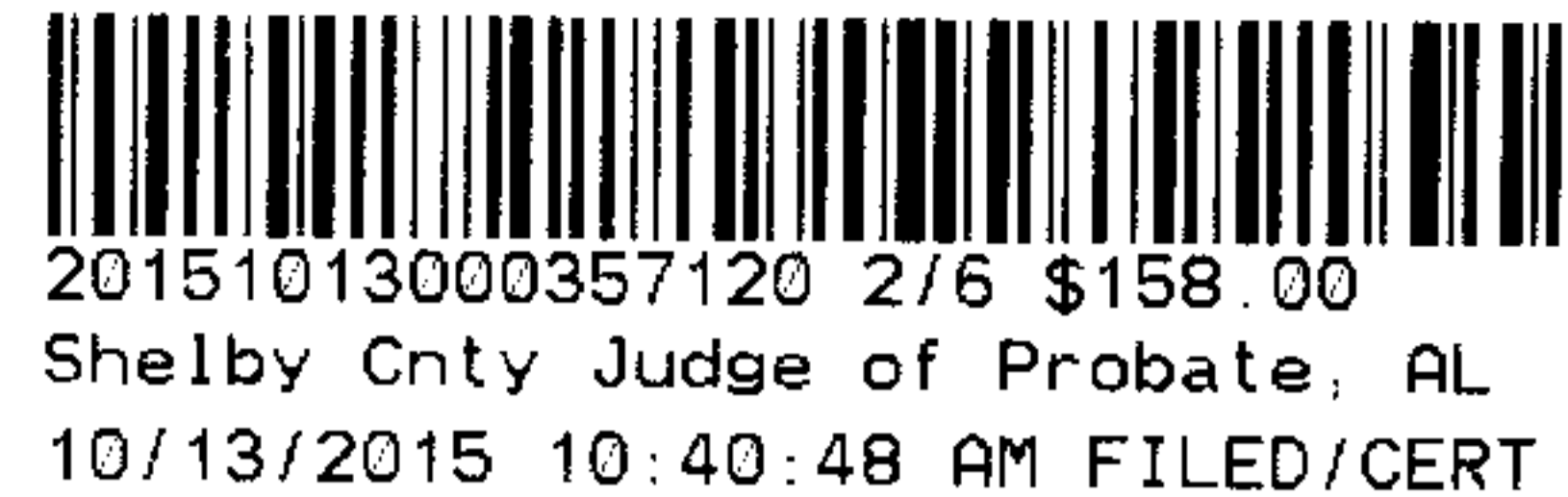

**ARTICLES OF ORGANIZATION
OF
WARD'S MAINTENANCE, RENOVATIONS AND HANDYMAN SERVICES, LLC**

The undersigned, being the Member and Organizer of the Limited Liability Company hereby being formed under the Alabama Limited Liability Company Law of 2014, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

Ward's Maintenance, Renovations and Handyman Services, LLC

SECOND: The term of existence of the Limited Liability Company shall be perpetual, unless the Limited Liability Company is sooner terminated by the occurrence of an event set forth in the Operating Agreement.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Alabama Limited Liability Company Law of 2014, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Alabama is 1054 Highland Village Trail, Birmingham, Alabama 35242, and the name of the initial registered agent of the Limited Liability Company to whom process may be sent in Alabama at that address is Sharon L. Ward.

FIFTH: The principal office of the Limited Liability Company is 1054 Highland Village Trail, Birmingham, Alabama 35242.

SIXTH: The Limited Liability Company is to be managed by the Managers. The names and addresses of the initial Managers are: Sharon L. Ward and Marcus D. Ward, The foregoing Managers shall serve as Managers until the first annual meeting of the Members or until their successors are duly appointed.

SEVENTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

EIGHTH: If there later are more than one Members, the remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any

other event which terminates the continued membership of a Member in the Limited Liability Company.

NINTH: The name and address of the sole Member and Organizer of the Limited Liability Company are: Sharon L. Ward, having an address at 1054 Highland Village Trail, Birmingham, Alabama 35242

TENTH: At the date of filing of these Articles of Organization, the Limited Liability Company has one Members.

ELEVENTH: The Limited Liability Company does not have the power to expel a Member.

TWELFTH: No the Members or parties to a contribution agreement or a contribution allowance agreement have preemptive rights.

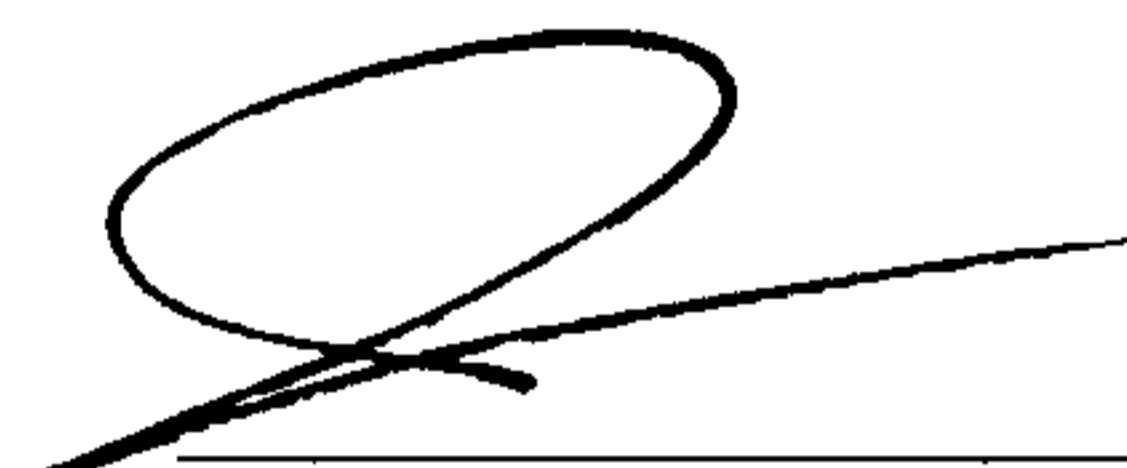
THIRTEENTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.

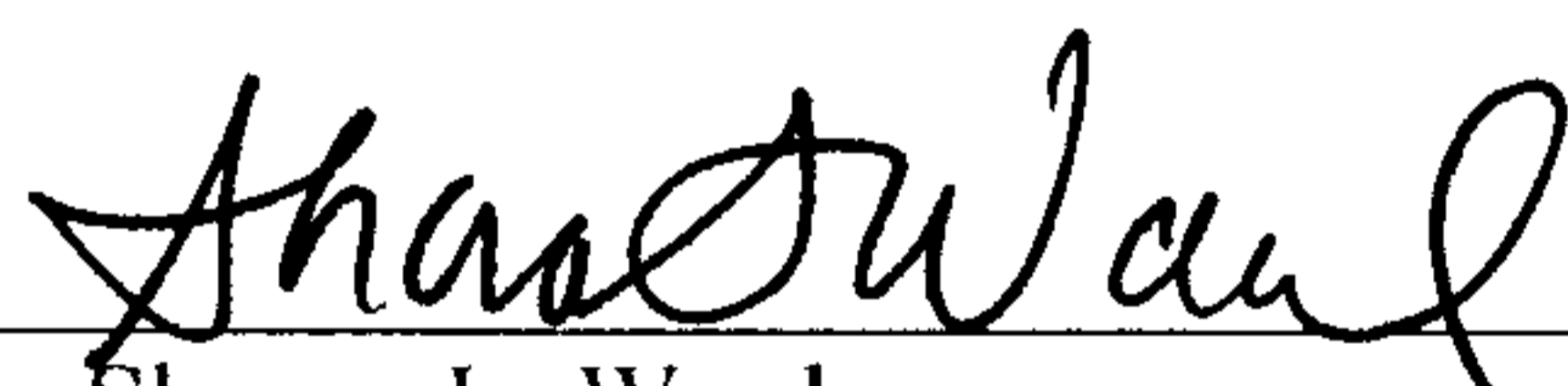

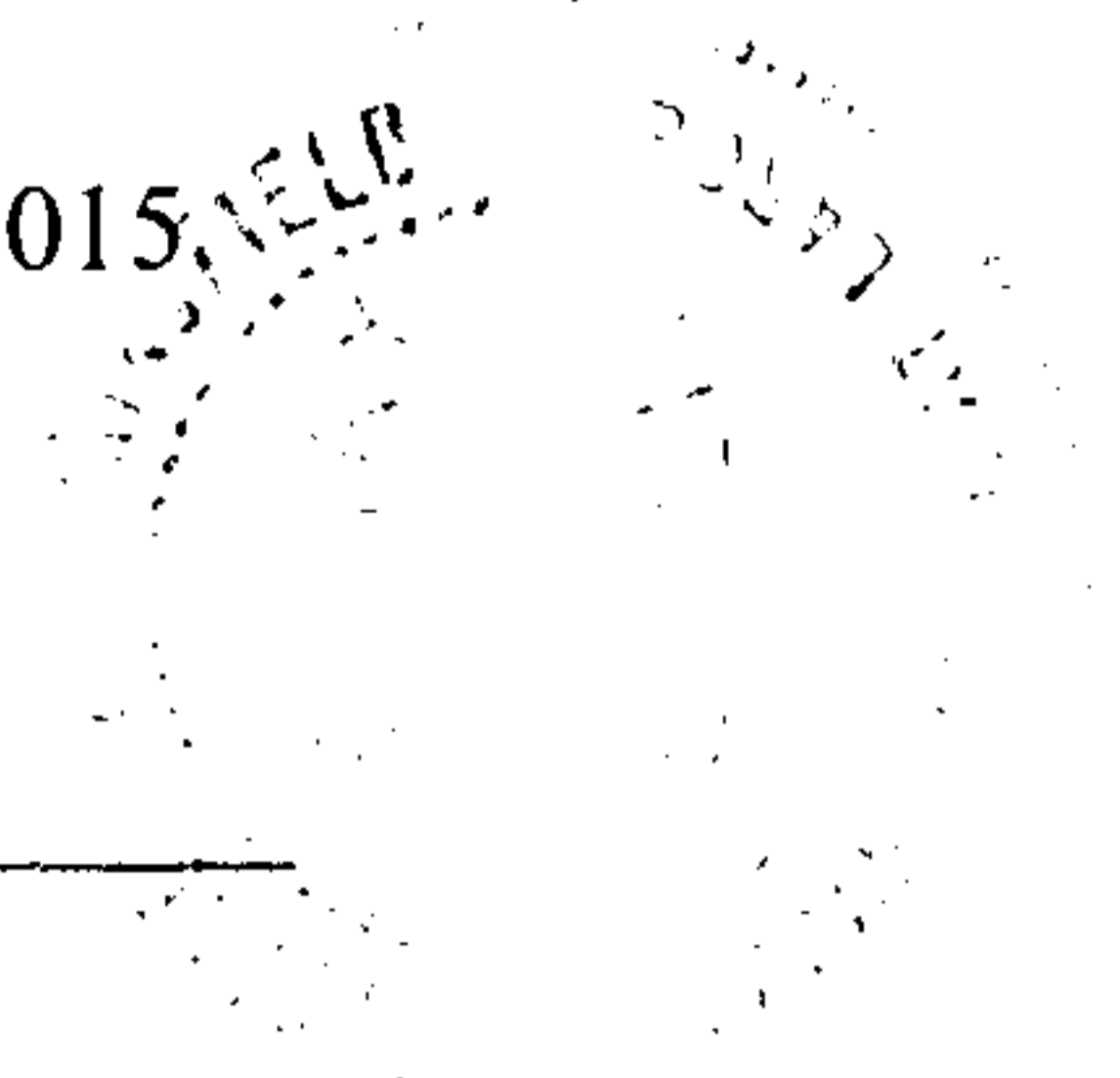
