Lot 190 as recorded in Map Book 22, Page 67, Shelby County, Alabama records

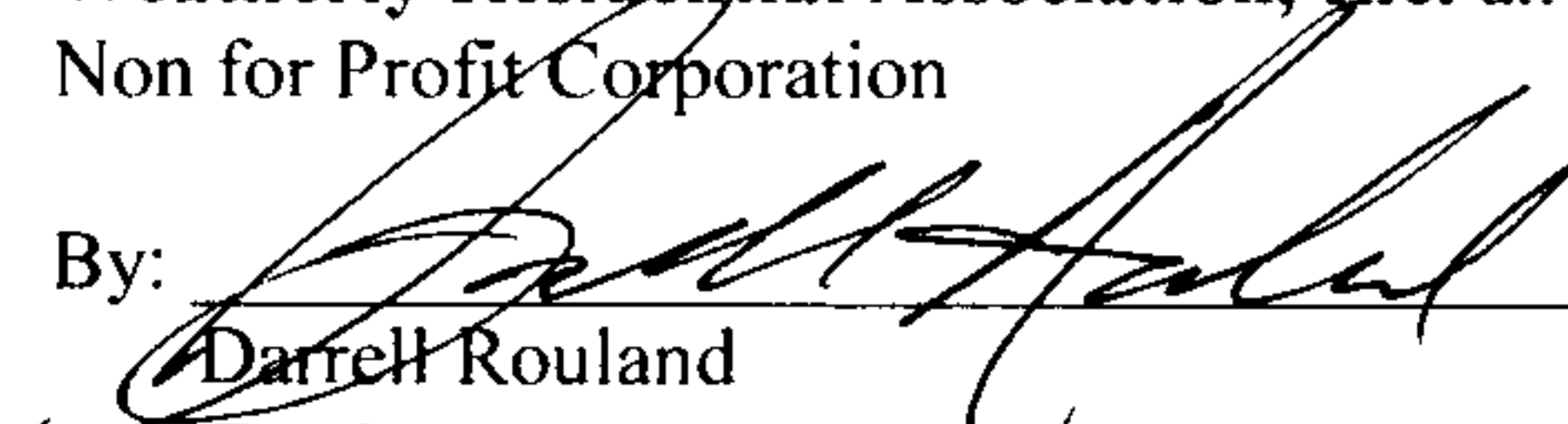

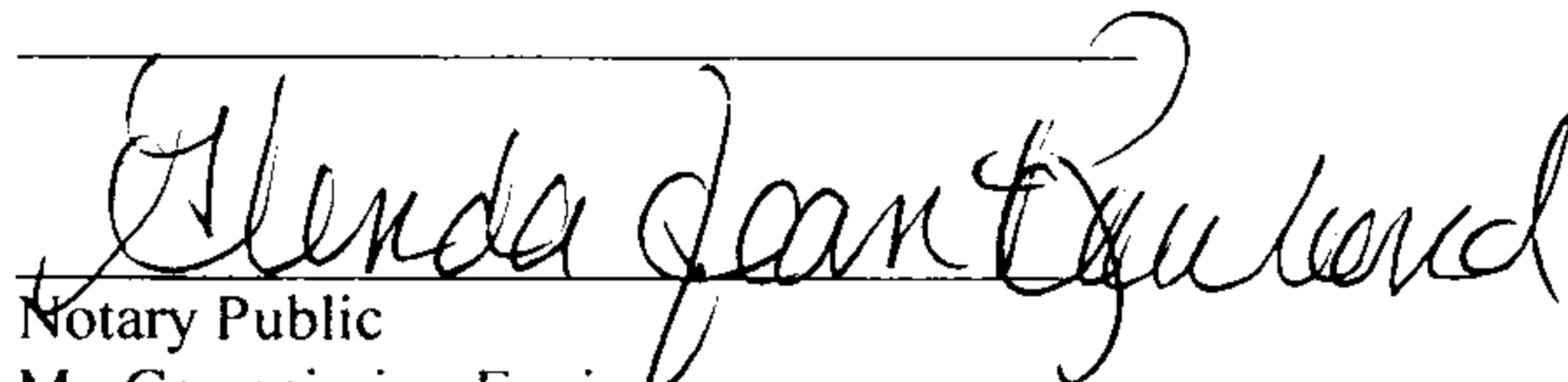
