


The property conveyed herein does not constitute the homestead of Sarah Kathryn Aycock nor that of her spouse.




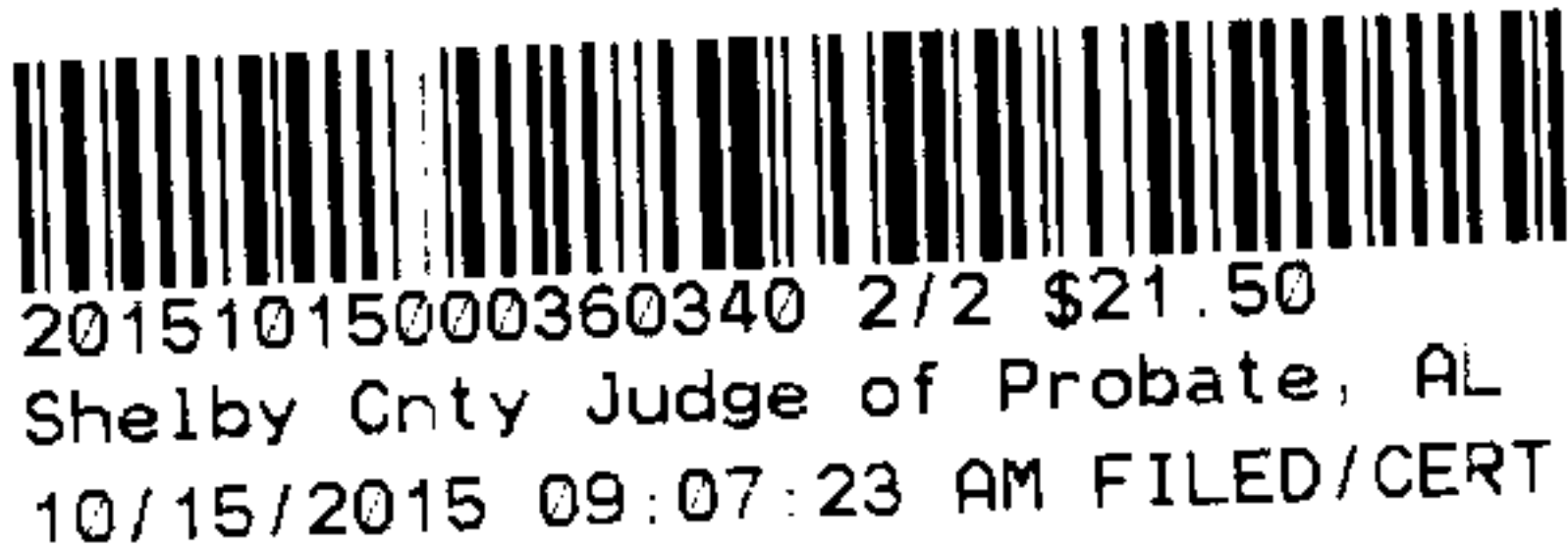
